## NOTIFICATION

On the recommendations of the committee, constituted to consider the requests of hostel residents for reducing their hostel fees and for adjusting hostel fees according to period of stay due to COVID pandemic situation, the Vice-Chancellor has ordered that following benefits will be given to the hostel residents for the session 2021-22:

- 1. All Differently Abled Students, with disability more than 50% and having family income from all sources up to six lacs, will be treated at par with Blind Students for the purpose of hostel fee waiver for the session 2021-2022. After getting requests of such students for fee waiver in the current session (2021-22), their hostel charges will be adjusted accordingly and the surplus amount paid by a hostel resident will be adjusted towards the second installment of hostel fees or will be refunded with the security of the hostel, if second installment has been paid already.
- 2. Hostel Charges (Room rent, water charges, electricity charges & additional establishment fund) whose sum per annum comes out Rs.15,900/- in total i.e. Rs.1,325/- per month (50% in case of BPL students), will be charged from the hostel residents in accordance to the period of allotment of hostel accommodation in months ,i.e., the period starting from the month of admission in the hostel up to the last month of the session 2021-22 as per academic calendar (i.e. month of June or August, whichever is applicable). If the number of days after allotment in the initial month of hostel are less than or equal to seven days, then the above mentioned charges for that month will also not be enforced. Surplus amount paid by a hostel resident, if any, will be adjusted towards the second installment of hostel fees on the request of a hostel resident to the concerned hostel warden or will be refunded with the security of the hostel, if second installment has been paid already. However, the other annual charges, as per applicable installment, will be charged from the hostel residents.
- In addition to the above, charges of Rs.1325/- (50% in case of BPL students) for one month
  of lockdown period i.e. for 03.01.2022 to 03.02.2022 will also not be charged from those
  students who were not present in the hostel during that period.
- 4. Hostel mess charges for actual number of days for which they have stayed and dined in the hostel and the fine waiver, which was permitted for the dues of the months of December and January by the Vice-Chancellor, are also allowed for the dues for the months of February and March, 2022.
- For further consideration of the issues of the hostel fee for the next session, a committee, consisting of Dean Students' Welfare, Chief Warden (Women) and Chief Warden (Boys), has been constituted. Students are instructed to give their requests to the committee.
- Benefits given to the hostel residents through earlier notifications in this session will also continue to be allowed.
