ACR-2/9(vi)/20/12778-877 dated 05.10.2020, keeping in view the revised schedule of admission for PG courses, the Vice-Chancellor has been pleased to revise the following common Schedule of Academic Calendar for PG courses only in the University Teaching Departments/Institutes on Campus only for the Session 2020-21 (for fresh candidates), subject to the further direction(s) from the State Government, if any:

FOR POST-GRADUATE COURSES

* Examinations be completed of each class within 25-30 days and all the work in this regard i.e. examinations, evaluation of Answer Books, etc. be got done in remaining days and during Vacations.

- Note: 1. There is no change in the other schedule of academic calendar i.e. PG courses in Even Semester and UG courses as earlier notified vide above mentioned notification.
 - 2. The schedule of Academic Calendar for PG courses for affiliated Colleges/Institutes for the session 2020-21 will be notified later on.
 - 3. The next academic Session 2021-22 in PG courses will start w.e.f. 01.09.2021.
 - 4. The classes will commence from 26.11.2020 in PG courses (Odd Semester) in the online/offline mode as per situation.
 - 5. If the number of teaching days falls less than 180 days (90 days in each semester) in the academic session 2020-21 due to some unforeseen reasons, it would be the responsibility of each Chairperson/Director to make good the loss by arranging extra classes.
 - 6. The State Universities are authorized to make minor changes/adjustment according to their local condition at their own level, keeping in view the condition of minimum 90 teaching days in each semester.
