Notification

Whereas vide order No. DMC-SPO-2020/12069 dated 13.11.2021 issued by the Chief Secretary-cum-Chairperson, Executive Committee of Haryana State Disaster Management Authority, preventive and the precautionary measures, to contain the Covid-19 pandemic, has been ordered to continue. In no case, any person without wearing mask and not following Covid appropriate behavior should be entertained for any office work in any office of the University.

As we all know that the University is open for students w.e.f. 22.11.2021, therefore, it is more important to follow SOPs for Covid appropriate behavior so that this pandemic disease remains under control. Cooperation of all sections of the University is highly desirable to keep the campus safe.
