As you are aware that the theory examination of UG 2<sup>nd</sup> & 4<sup>th</sup> Semester are scheduled to commence w.e.f. 11.07.2022 onwards and the Academic Branch vide Endst. No. ACR-2/9(ix)/22/7704-18 dated 24.06.2022 has conveyed to get conduct the practical examinations of all the UG Courses (2<sup>nd</sup> & 4<sup>th</sup> Semester) before the commencement of the theory examinations of the aforesaid courses. Furthermore, the practical examinations of UG courses (6<sup>th</sup> Semester) may also be got conducted immediately after the termination of the theory examinations of the concerned courses.

The appointment of practical examiners will be made by you from the panel which will be supplied to you shortly by the Conduct Branch. In case, the practical examiner recommended in the panel doesn't turn up or refuses to perform the duty, in such a case, the Director/Chairperson/Principal will be authorized to appoint the examiners from the nearby college. While appointing the external examiner, the concerned Director/Chairperson/Principal will keep in view the aspect that the travel distance of external examiner should not be more than 100 Kms. (Each side). The examiner will not be appointed on reciprocal basis and must not be repeated each year. The practical examinations of re-appear candidates will be got conducted in their ex-colleges.

After completion of practical examinations, you are requested to upload the marks at University Portal and the hard copy of the same will be deposited to the Assistant Registrar (Secrecy) within a week under a sealed cover. The remuneration bills duly verified by the concerned Director/Chairperson/Principal along with appointment lists & TA/DA bills duly completed in all respect may be sent to the Assistant Registrar (Conduct), Kurukshetra University, Kurukshetra.
