



Kurukshetra to discuss regarding the grant of provisional affiliation to existing Associated Sanskrit Institutes of the K.U. Kurukshetra (Change of status from Associate/Regular Affiliation to permanent Affiliation).

**RECOMMENDATIONS OF THE COMMITTEE**

After detailed deliberations, the Committee recommends as under:-

- (1) The Committee perused the request of eight Sanskrit (Seven associated Sanskrit Institutes and one Sanskrit affiliated College) and noted that these Sanskrit Institutes associated with the K.U. Kurukshetra are running the Acharya, Visharad and Shastri courses.
- (2) That these associated Sanskrit Institutes will submit the Registration Return of the admitted students with prescribed fee like affiliated Sanskrit college.
- (3) That these associated Sanskrit Institutes will get themselves registered on IUMS Portal of K.U. Kurukshetra and will submit the examinations forms of the admitted students like the affiliated Sanskrit college.
- (4) That in any case associated Sanskrit Institute required affiliation like a Sanskrit college then they will have to fulfill the preliminary conditions prescribed in the University Calendar for opening a new Sanskrit college to run the Acharya, Visharad and Shastri courses.
- (5) There will be a sum of Rs. 2000/- +18% GST as annual continuation fee remitted by the Associated Sanskrit institutes w.e.f. the session 2022-2023.
