

**GUIDELINES FOR PUBLICATION OF ARTICLE IN KURUKSHETRA LAW JOURNAL**

Notwithstanding to the applicability and contrary with the UNIVERSITY GRANTS COMMISSION (PROMOTION OF ACADEMIC INTEGRITY AND PREVENTION OF PLAGIARISM IN HIGHER EDUCATIONAL INSTITUTIONS) REGULATIONS, 2018; as notified in gazette of India dated 31.07.18. The following guidelines are framed for the publication of research articles in Kurukshetra Law Journal to curb the Plagiarism/copyright violation in research and publication of research articles and an endeavor shall be made to raise the standard in publication of research articles by blind review of articles. The below mentioned guidelines will be applicable w.e.f from publication of Vol VIII (2018) of Kurukshetra Law Journal.

Kurukshetra law Journal is a refereed research based journal in the field of Law; Academicians in the field of research, teaching and research scholars; who are pursuing for doctoral programme can submit manuscript of research articles. Only research articles will be entertained and no informative articles will be entertained.

**A. Guidelines for by the Authors-Contributors Regarding Submission of Articles**


1. Kurukshetra Law journal accepts submission of manuscripts of research articles only via e-mail and research articles received by any other means will not be accepted.
2. All the manuscripts of research articles shall be submitted to the Editor via (E-mail: chairperson.law@kuk.ac.in)
3. Manuscripts of research articles, Case Comments and Book reviews should not be longer than 3000, 1000 and 500 words respectively excluding footnotes.
4. Contributors shall submit their manuscript (Word file) of research articles with 1.5 spacing New Times Roman Font 12 and with a margins of 1 inch on both sides. The main title should be in Capitals, bold and 16 point font and the authors name should be in small capitals. The footnotes shall be in single spacing, New Times Roman Font 10.
5. The contributors/authors have to submit a certificate duly signed (PDF version) that the submitted manuscript of research articles is research based article and nowhere submitted for publication and no copyright violation/plagiarism is made by the contributors and not in violation of regulation of University Grants Commission (Promotion of Academic Integrity and Prevention of Plagiarism in Higher Educational Institutions) Regulations, 2018 as notified in Gazette of India dated 31.07.18. (Appendix -I)
6. Mode of Citation

**(i) Citation of Books / Edited Books**

Name of the author, (where more than two use Name of first two authors only, and *et.al*), Title of the book Publisher, Place of publication, and edition/year of publication, page no.

**(ii) Citation of a paper published in a Journal/Periodical:**

Name of author of the article (where more than two use Name of first two authors only, *et.al*), title of the paper within inverted commas, volume number of journal Name of the journal in abbreviation page number (year).

(iii) Citation of a paper published in an edited book:

Name of author (where more than two use name of first two authors only, *et.al*), title of the paper within inverted commas, name of the editor(s), *title of the edited book* page number (publisher, edition/year).

(iv) Citation of Websites

If the website gives information as to when it was last modified, the same must be cited. If not, then the author must indicate the date of visiting the website.

E.g. Law of Bodily Autonomy available at: <http://www.bodilyautonomy.bill.aq/a> (Last Modified April 29, 2018).

E.g. Law of Bodily Autonomy available at: <http://www.bodilyautonomy.bill.aq/a> (last visited on October 29, 2003).

(v) Citation of Case Law

i. Where the case title is written in the body of the text, only the name of the case shall be in the text e.g. *Sunil Batra v. Delhi Administration* and the citation is written in the footnote as AIR 1980 SC 1579.

ii. If the name and citation are to be written in the footnote itself:

*Sunil Batra v. Delhi Administration*, AIR 1980 SC 1579.

(vi) Citation of Acts and Sections of the Act

The Information Technology Act, 2000 (Act 21 of 2000).

The Information Technology Act, 2000 (Act 21 of 2000), s. 30

The Information Technology Act, 2000 (Act 21 of 2000), ss. 30, 32.

(vii) Citation of Reports

E.g. Government of India, Report: Committee on Reforms of Criminal Justice system (Ministry of Home Affairs, and the Year)

(viii) Citation of Unpublished Research Work (E.g., Dissertation/Thesis):

Name of the Researcher, *Title of the dissertation/thesis* (Year) (Unpublished Ph.D. thesis, Name of the University/institutes/organization).

iii. Citation of Forthcoming publication of a book and article

E.g. Surinder Singh, *Information technology* (In Press, 2018).

Use of References

i) *Supra* and *Infra*

*Supra* is cited to refer prior footnote.

E.g. *Supra* note 10 at 7.

Avoid use of *Infra*



B. Second Step: -Blind Review of Article

- i. To go for blind review (without disclosing the name of contributor) for the research based article /contribution for the purpose of publication of research articles; there shall be a

- Committee Headed by Dean, Faculty of Law having Editor of Kurukshetra Law Journal/Chairperson of the Department, all Professors of the Department.
- 2 Assistant Editor of the Journal will ensure that the research articles(s)/book reviews/case comments are received with in time via E-Mail.
  - 3 To elevate the research standard of the Journal; the Committee headed by Dean Law shall meet and prepare a panel of Professors (referees/evaluators) in the field of Law, outside the University (external) and articles shall be sent to the referees for blind review; the research articles shall be sent to referees by the Dean Law and Chairperson/Editor of Kurukshetra Law Journal; the process of blind review of articles shall be Confidential.
  - 4 Referee has to submit a report that the article is research based article. In case, if any suggestion is given by the referee; the same shall be communicated to the contributor for incorporation before publication of article. (Appendix -II).

1. The copy of above guidelines shall be sent to referees along with the manuscript.
2. All the above guidelines shall be published on the last pages or back pages of Kurukshetra Law Journal as "Guidelines for Contributors" as well as on the Website of Kurukshetra University.
