Whereas the MHA Govt. of India, vide its order No. 40-3/2020-DM-1(A) dated 17.05.2020 has extended the lockdown for a further period of another 14 days w.e.f. 18th May, 2020 to 31th May, 2020 and in compliance of notification of Director, General Health Services, Govt. of Haryana order memo No. 32/3-IDSP-020/3318-24 Dated 27-5-2020, I, Dhirendra Khadgata, IAS, District Magistrate-cum-Chairperson, District Disaster Management Authority, Kurukshetra in exercise of the powers conferred under the epidemic disease act 1897 (as amended from time to time) hereby issue the directions:-

- 1. The Central Government and the State Government have made it very clear that in the interest of public safety during the prevailing of pandemic wearing of a Face Cover whether a mask, an improvised mask, a home-made mask or a face cover using clean clothes shall be mandatory for every person while being in public places and a workplace
- 2. Also there needs to be strict prohibition of spitting in public places
- 3. Now, therefore, it is ordered that every violation of the above these prohibitions will be punished by imposing fine of Rs 500/- Non-payment of fine by the Violator will attract proceedings under section 188 of IPC.

Every officer designated below shall be responsible for implementation of these directions -

- a. BOPO, Tehsildar and Naib Tehsildar of the district Kurukshetra.
- b. Executive Officers/Secy. of Municipal Council/Committees of the district Kurukshetra.
- c. Station House Officers of the district Kurukshetra.
- d. Medical officers as designated by concerned Civil Surgeon for concerned Hospital/CHC/PHC premises of the district Kurukshetra.
