

- a) The minutes of the meeting of IQAC Committee held on January 13, 2017 was approved
- b) A presentation of the format for Department Academic Performance Index (DAPI) was made and discussed thoroughly. The Committee agreed in principle to introduce the concept of DAPI in the University departments and recommended to constitute the sub-committee(s) for more suggestions before finalization of the format in a time – frame.
- c) The Committee discussed the creation of Professional Development Fund (PDF) for the PI/Co-PIs of the research project and recommended that the status-quo be maintained in this regard.

- d) The Committee discussed the modifications in the students' feedback Performa and recommended that a committee be constituted for this purpose to modify the profirma as per NAAC guidelines.
- e) It was recommended to hold the meeting of IQAC Committee frequently atleast twice in a Semester.

The meeting ended with a vote of thanks.


