- 1. The CBCS will be extended to all campus programs including UG/PG, Certificate, Diploma, PG/Advance Diploma w.e.f. the session 2020-21. An open elective paper of zero credit may be introduced in the programs where open elective paper of credit 2 is not feasible subject to the provisions of regulatory bodies.
- 2. The CBCS will be implemented for UG/PG programmes in the affiliated Colleges w.e.f. the session 2020-21.
- 3. The Academic Branch will take necessary steps for framing rules and guidelines for the implementation of CBCS in UG and other programmes. The rules and guidelines for PG programmes already exists.
- The Committee recommended that Scheme/Syllabi of all the UG/PG programmes would be revised/reformatted w.e.f the Session 2020-21 by including Programme outcomes (POs), Programme Specific Outcomes (PSOs) and Course Outcomes (COs) and their attainment in each programme. IQAC of the University will circulate the necessary template for the same.
