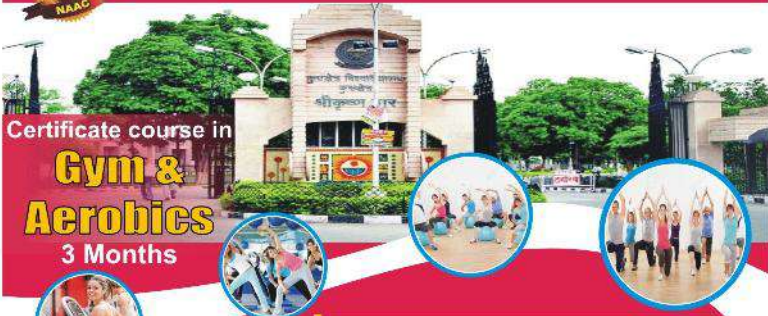

Seven Day and Night Special Camp at Village Dayalpur

Under the directions of Hon'ble Vice Chancellor Dr. Som Nath Sachdeva and Dean Students' Welfare Prof. Anil K. DAY 1

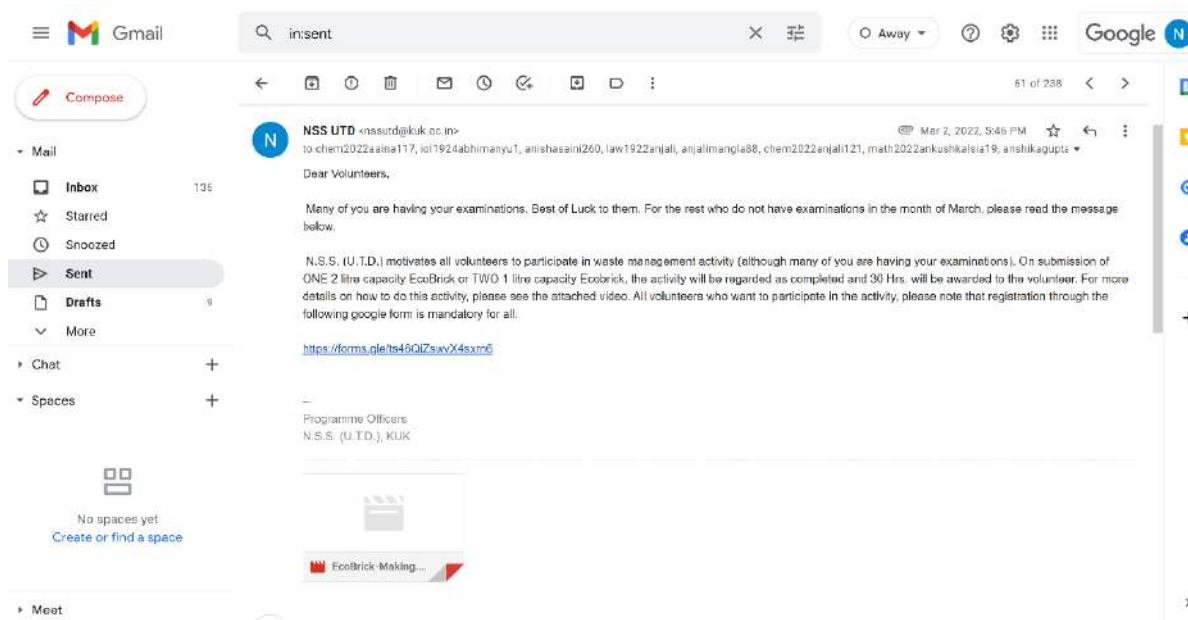

6. Waste Management Activity Eco-Brick from Plastic Waste

The volunteers registered online for this activity and 62 students participated in the activity. The volunteers filled the EcoBrick over a course of 20 days and once full, the EcoBricks were submitted to the Programme Officers.

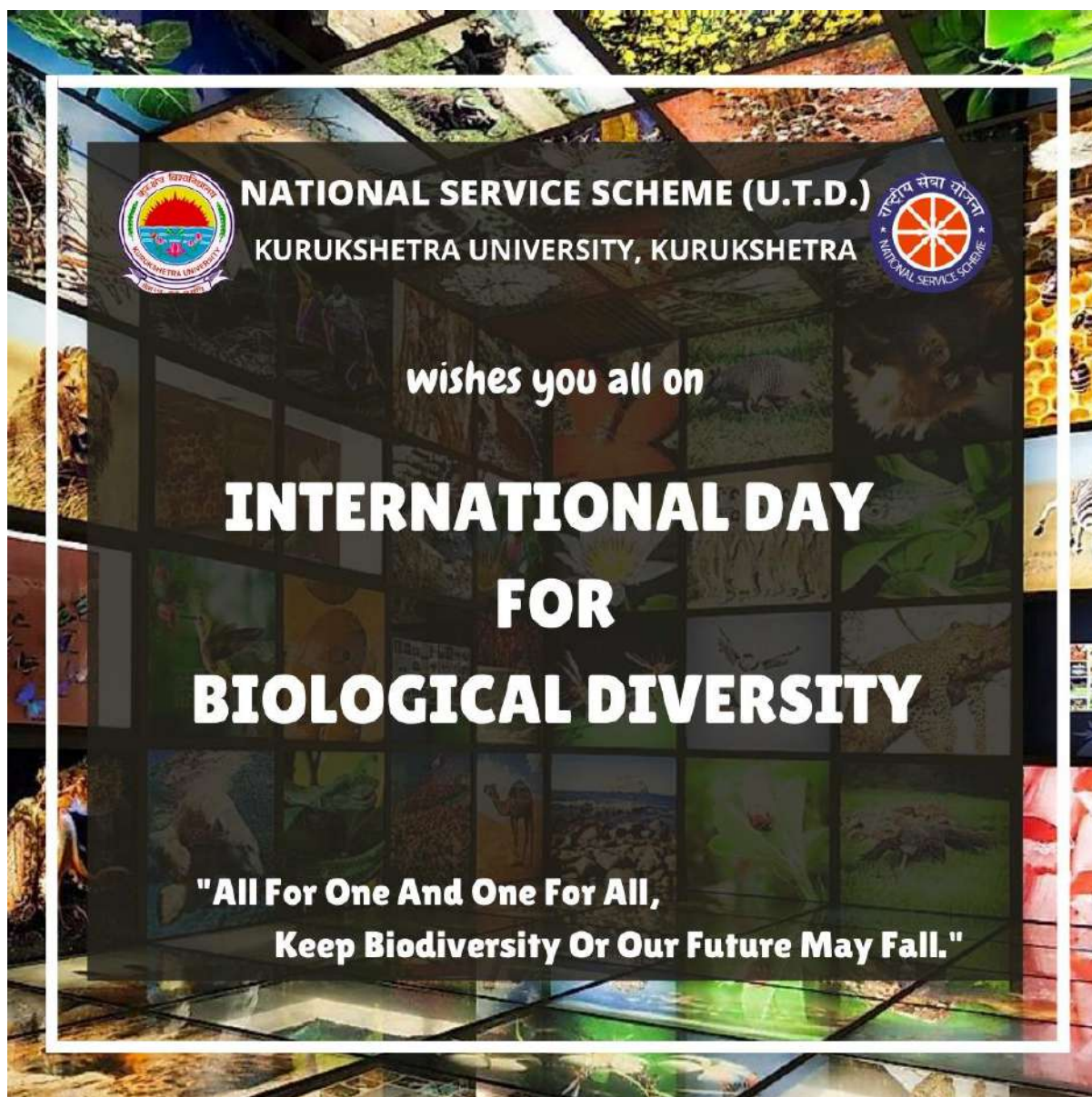

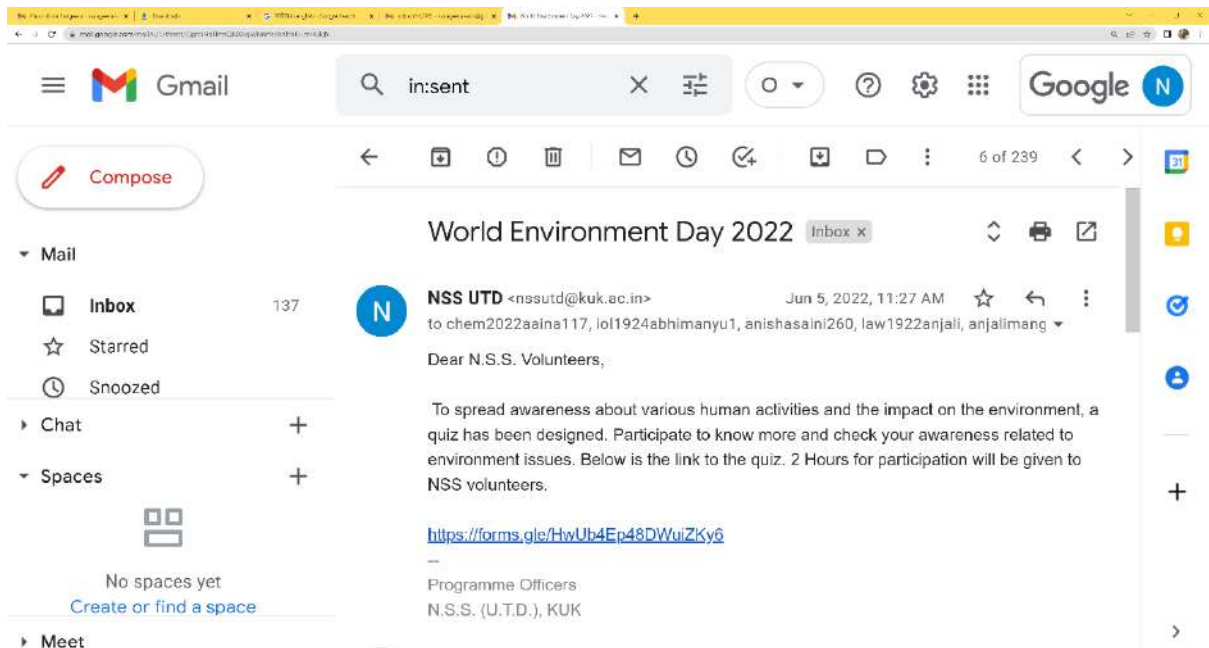

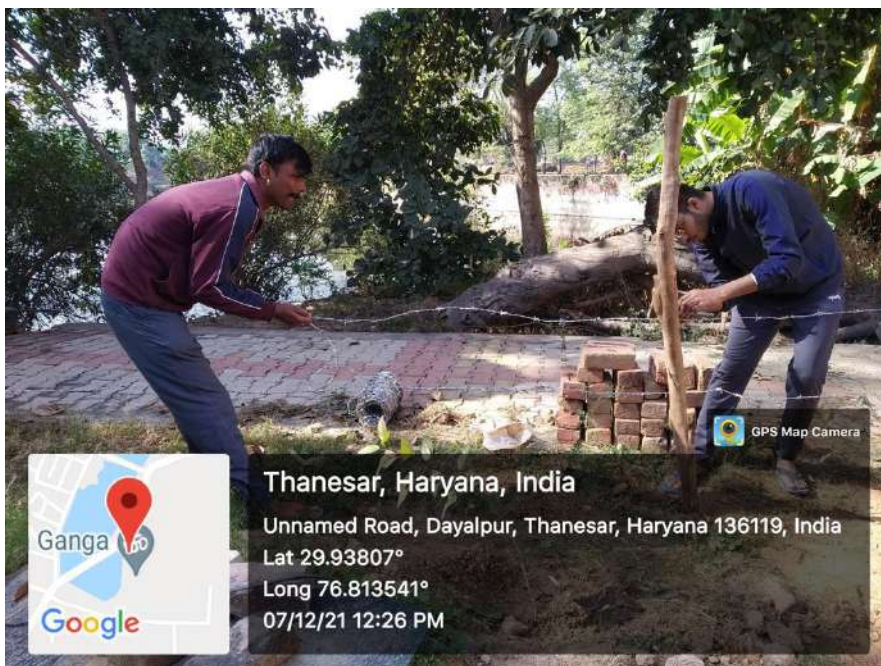

N.S.S. (U.T.D.), Kurukshetra University, Kurukshetra on the eve of World Environment Day (celebrated every year on 5th June) organized One Day Camp “One Earth for all” on 1st of June, 2022. Several pre-event meetings were held with NSS volunteers. The volunteers were enthusiastic about celebrations and proposed to design Quiz to create awareness among students on environment issues. Subject: Proposal to organize Research Methodology Workshop from 02nd August to 07th August, 2021.

Department of Commerce, Kurukshetra University, Kurukshetra proposes to organize one-week Workshop on Research Methodology, focusing on Questionnaire Development and Structural Equation Modelling from August 2, 2021 to August 7, 2021. It is proposed to organize the workshop in offline mode, following all the guidelines of COVID-19 pandemic, issued by the government at that time.

Presently 30 Research Scholars are pursuing Ph.D. in disciplines of Marketing, HR and Finance. Structural Equation Modelling (SEM) is a Statistical Methodology that is widely used in Social Sciences Research (especially Marketing, Organizational Behavior, Human Resource Management, Psychology, Behavioural Finance and Behavioural Economics). SEM models are so general that they encompass most of the statistical methods that are currently used in the social and behavioural sciences. SEM allows a researcher to test complex models with multiple pathways, model latent variables with multiple indicators, investigate mediation and moderation in a systematic way and adjust for measurement error in predictor variables. This workshop shall provide the participants an in-depth knowledge on theoretical and practical aspects of SEM, moderation and mediation. Since the workshop is on highly specialized area of research methodology, the resource persons take full day sessions and to have continuity of training, they shall be requested to complete the full modules assigned to them.

Venue: Senate Hall/ Faculty Lounge/Department of Commerce.

Target Audience: Faculty members and research scholars in the discipline of Commerce, Management, Tourism, Mass Communication, Economics, Psychology, Education etc. will be invited. 1. The syllabus of Paper-III(a) comprises of 15 hours of teaching theory and 15 hours of practice. The cause curriculum for the theory comprises of the topics on philosophy and ethics, scientific conduct and publication ethics.
