## National Education of Policy 2020

### Abstract

On 29 July 2020, the Government of India cabinet approved a new National Education Policy with an aim to introduce several changes to the existing Indian education system. The purpose of the education system is to develop good human beings capable of rational thought and action, possessing compassion and empathy, courage and resilience, scientific temper and creative imagination, with sound ethical values. It aims at producing engaged, productive, and contributing citizens for building an equitable, inclusive, and plural society as envisaged by our Constitution. Here in this research paper I would like to share my views on Adult Education, Vocational Education and also in Teacher Education in the National Education policy.

### Introduction

The National Policy on Education (NPE) is a policy formulated by the Government of India to promote and regulate education in India. The policy covers education from Early Childhood Care and to higher Education in both rural and urban India. The first NPE was promulgated by the Government of India by Prime Minister Indira Gandhi in 1968, the second by Prime Minister Rajiv Gandhi in 1986, and the third by Prime Minister Narendra Modi in 2020. Cabinet under Prime Minister Narendra Modi has given approval to a new education policy of 21st century. It is equally important and essential as there were no changes in the education policy for last 34 years. 10+2 structure in school education will be modified with a new pedagogical and curricular restructuring of 5+3+3+4 covering ages from 3 to 18. Currently, children in the age group of 3-6 are not covered in the 10+2 structure as Class 1 begins at age 6. In the new 5+3+3+4 structure, a strong base of Early Childhood Care and Education (ECCE) from age 3 is included. Some points of the policy are analysed here and discussed for its importance in school education system.
