RECOMMENDATIONS OF THE COMMITTEE


- (1) After detailed deliberations the Committee recommends that the sanctioned intake be fixed of 60 seats in each courses in the Associated Sanskrit Institutes to run the Vishard and Shastri courses w.e.f. the session 2022-2023 without charging any application/affiliation fee from the Associated Sanskrit Institutes.
- (2) The Associated Sanskrit institutes will upload their data of admitted students on University portal upto 15-12-2022 without late fee.
- (3) No further admissions shall be allowed without permission of the University beyond the ~~above~~ sanctioned seats.
