

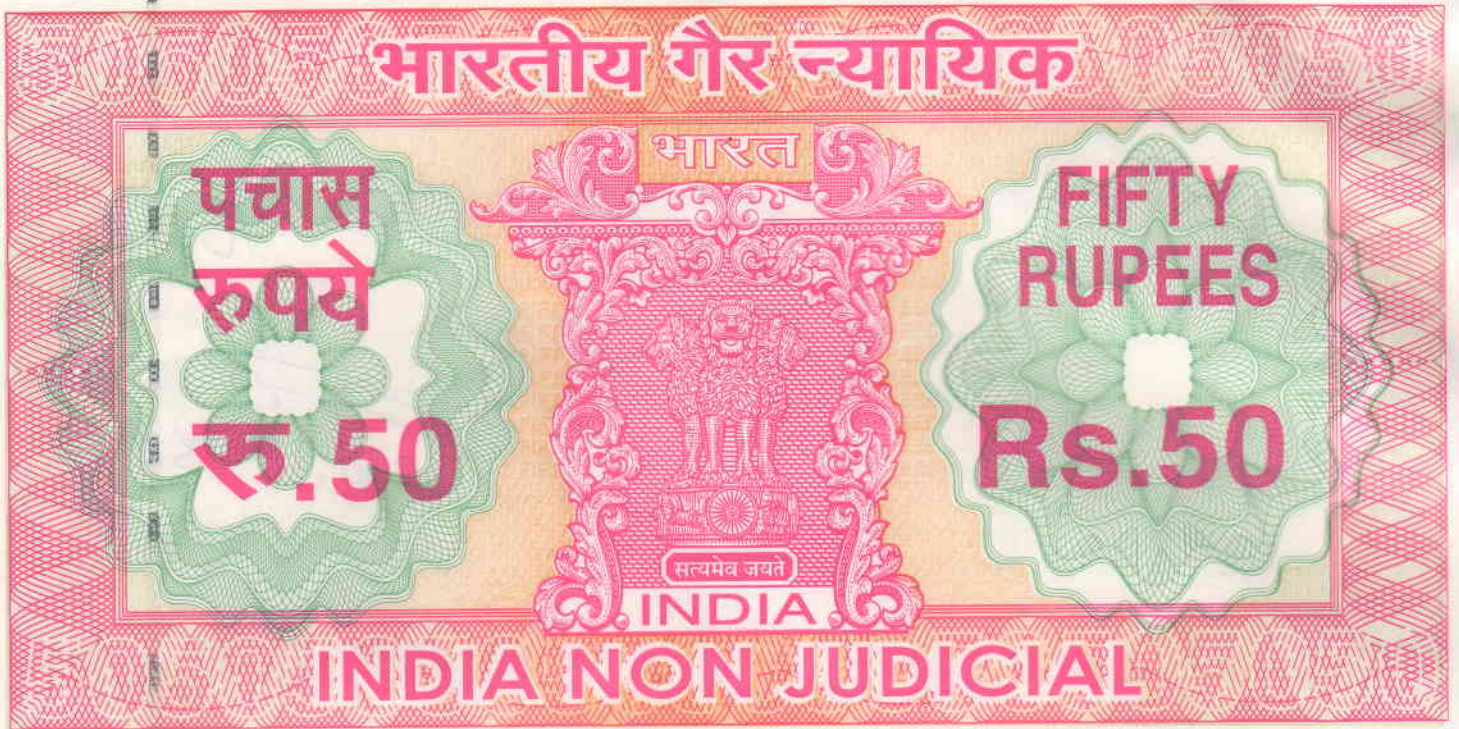
2. The Partner shall be responsible for providing the requisite infrastructure, network , internet access, accommodation/food/transport (as per University norms) to the trainers and any other facility required for the on-campus training. There shall be no financial liability for the partners to MOU expect in case of training scheduled by the partner.
3. Trainings will be planned as per schedule mutually agreed upon by both the parties.
4. The Partner shall provide First slot to CodeQuotient during campus placements for hiring the students trained by CodeQuotient. And selected students would not be allowed to appear in any further campus placement drive, offering the same/less salary package.
5. Both the parties agree that CodeQuotient is not obliged on account of this MOU to recruit any fixed number of students from the Partner.
6. Both parties hereby agree to designate a representative from its side who will be the primary point of contact on behalf of that party.
7. Both parties shall take all reasonable steps to ensure the successful completion of the collaboration, and co-operate with each other in duly carrying out the obligation agreed upon.
8. Each of CodeQuotient and Partner may use the name and logo of the other Party (with prior approval) in commercially reasonable marketing, advertising and/or publicity releases, and describe work completed under this Agreement in summary and general form, without revealing any of the other party's confidential information so long as the relationship between the Parties is accurately portrayed, without securing additional written approval of the other Party.
9. Each party shall ensure that they do not actively solicit the faculty of the other party who is involved in the implementation of this MOU during the period of such faculty's involvement with the program and for twelve (12) months thereafter.
10. Each party shall respect the other's intellectual property (IP) and shall not use any trade name, trademark, symbol or designation belonging to the other, without prior written approval. No party shall hold out as an agent or representative of the other or create any liability for the other. The parties shall indemnify the other for the breach of this clause.
11. Both parties shall maintain confidentiality about any information, course material, plans, discussions, strategies or any material which shall be deemed to be confidential and marked accordingly. Any information, course material or the like in the public domain shall not be part of this commitment.



12. This MOU shall be valid for 3 years from the date of signing and each party shall be at full liberty to terminate the collaboration, with a notice period of 3 months.
13. The parties hereby agree that they are not bound exclusively by this MOU and are at liberty to enter into any separate agreements or arrangements with any third party without reference to the other party.
14. This MOU is an indication of good faith and intent on the part of both parties and does not create any legal obligations between them. In the event of any differences or disputes arising from the implementation of the provisions of this MOU, the parties shall as far as possible settle such differences or disputes in good faith by consultation or negotiation between the parties.
15. This MOU shall be governed by the laws of India and Hon'ble High Court of Punjab and Haryana at Chandigarh shall have exclusive jurisdiction.

#### **ARTICLE II- Research collaboration**

The parties shall actively engage in research work through,

- a. Joint research projects funded by the government, private parties and individuals
- b. Support research students/scholars interested in working on themes related to Srimad BhagwadGita
- c. Provide facility for the exchange of researchers and academicians and offer them all possible support in the form of access to their facilities

#### **ARTICLE III- Extension activities**

The parties shall,

- a. Support the Govt. and non-Govt. organizations in preparing vision document of the Kurukshetra city incorporating the theme of BhagwadGita.
- b. Work for starting dedicated TV Channel/ community radio broadcasting and other media
- c. Promote and facilitate cultural activities, competitions for the students of schools/ colleges and for general public

#### **ARTICLE IV -Obligations of the parties**

- a. Both the parties shall abide by the terms and conditions of this MoU as permissible by their respective Acts and Statues. There shall be no financial obligation on the part of any party under this MoU.
- b. However GGS can support research and academic activities in the university at its own volition.

- c. Each party shall nominate a member of its staff as Nodal Officer to coordinate the activities arising under this MoU.

#### ARTICLE V- Duration, Amendment, Termination and dispute Resolution


- a. This Memorandum of Understanding may be amended by mutual consent by both the parties expressed in writing.
- b. The MoU is initially signed for a period of 3 (Three) years commencing from the date of signing and may be renewed by mutual consent on same/amended terms.
- c. Both KUK and GGS shall have the right to terminate this MoU by giving 3 (Three) months written notice to the other party. Such termination shall not the ongoing activities till completion.
- d. Both Parties shall endeavor to amicably settle any dispute arising during the execution of this Memorandum of Understanding. In case of any dispute, the jurisdiction will be of the district courts Kurukshetra.

Three copies of this MoU equally valid (two for KUK and one for GGS) are hereby signed effective from the date of its signing.

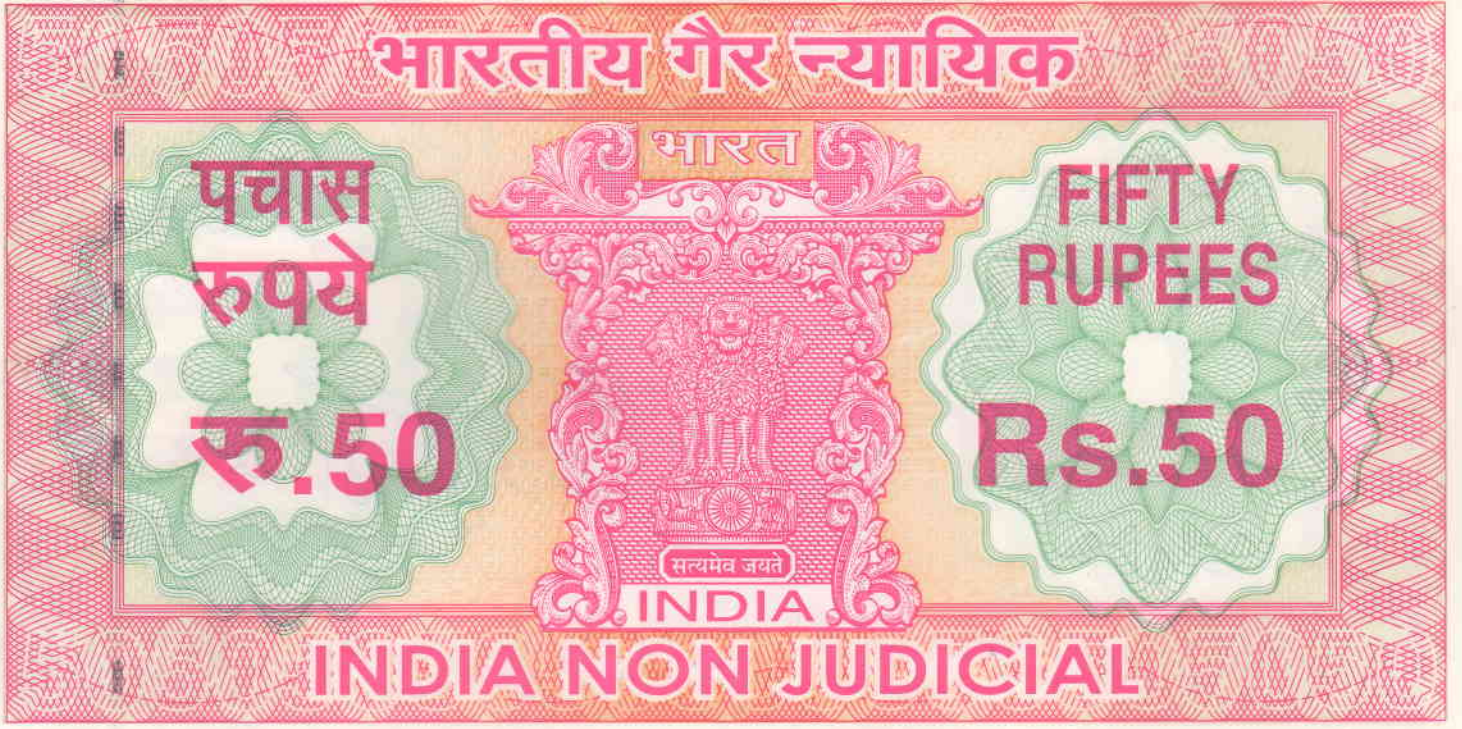

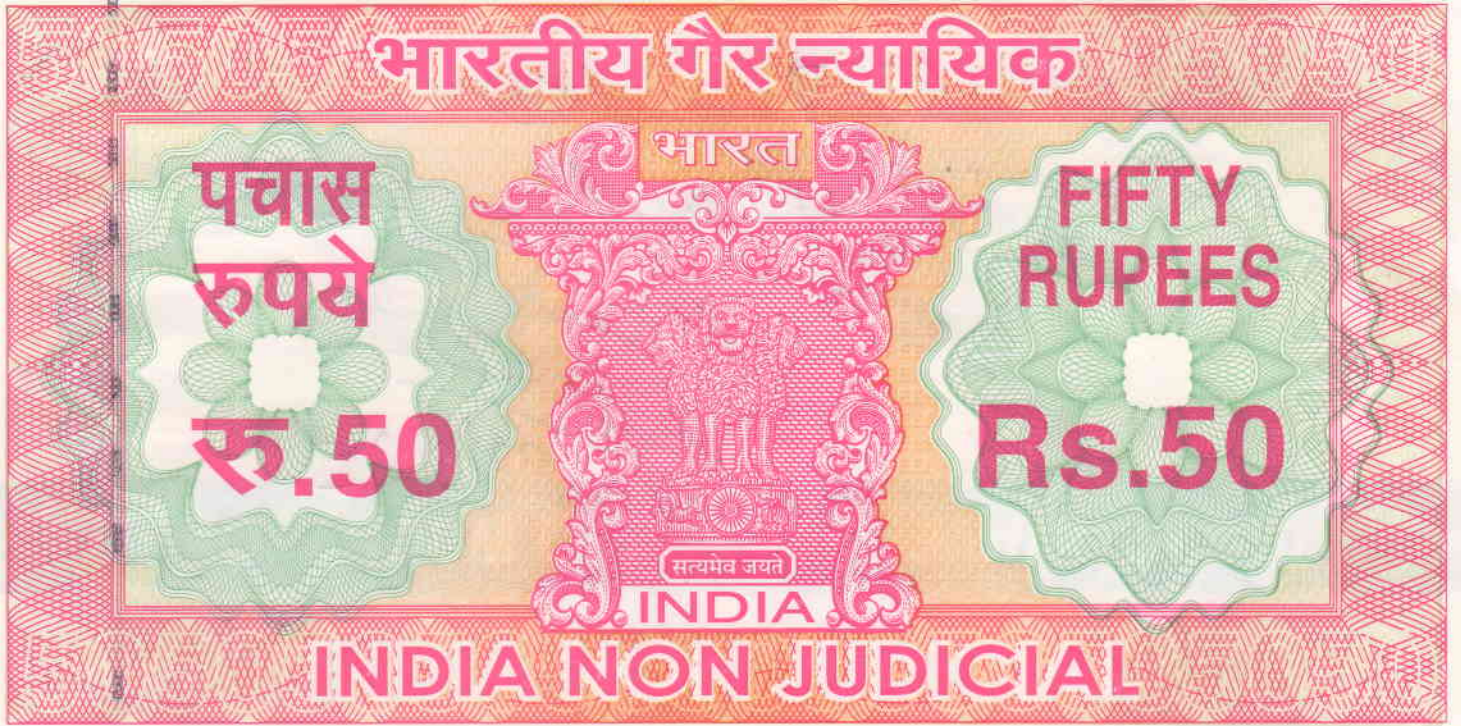

**NOW THEREFORE, IN CONSIDERATION OF THE MUTUAL PROMISES SET FORTH IN THIS MOU, THE PARTIES HERE TO AGREE AS FOLLOWS:**

**CLAUSE 1 CO-OPERATION**

- 1.1 Both Parties are united by common interests and objectives, and they shall establish channels of communication and co-operation that will promote and advance their respective operations within the Institution and its related wings. The Parties shall keep each other informed of potential opportunities and shall share all information that may be relevant to secure additional opportunities for one another.
- 1.2 First Party and Second Party co-operation will facilitate effective utilization of the intellectual capabilities of the faculty of First Party providing significant inputs to them in developing suitable teaching / training systems, keeping in mind the needs of the industry, the Second Party.
- 1.3 The general terms of co-operation shall be governed by this MOU.

**CLAUSE 2 SCOPE OF THE MoU**

- 2.1 The budding graduates from the institutions can play a key role in technological up-gradation, innovation and competitiveness of an industry. Both parties believe that close co-operation between the two would be of major benefit to the student community to enhance their skills and knowledge.
- 2.2 **Curriculum Design:** Second Party will give valuable inputs to the First Party in teaching / training methodology for better training & placement of students.

- 2.3 **Industrial Training & Visits:** Industry and Institution interaction will give an insight into the latest developments / requirements of the industries; the Second Party to permit the Faculty and Students of the First Party to visit its group companies and also involve in Industrial Training Programs for the First Party. The industrial training and exposure provided to students and faculty through this association will build confidence and prepare the students to have a smooth transition from academic to working career. The Second Party will provide its Labs / Workshops / Industrial Sites for the hands-on training of the learners enrolled with the First Party.
- 2.4 **Internships and Placement of Students:** Second Party will actively engage to help the delivery of the Internship and placement of students of the First Party into internships/jobs.
- 2.5 **Research and Development:** Both Parties have agreed to carry out the joint research activities in the fields of – Printing and Packaging Technologies.
- 2.6 **Skill Development Programs:** Second Party to train the students of First Party on the emerging technologies in order to bridge the skill gaps and make them industry ready.
- 2.7 **Expert Lectures:** Second Party to extend the necessary support to deliver expert lectures to the students of the First Party on the technology trends and in house requirements.
- 2.8 **Faculty Development Programs:** Second Party to train the Faculties of First Party for imparting industrial exposure/ training as per the industrial requirement considering the National Occupational Standards in concerned sector, if available.
- 2.9 **Start ups/Entrepreneurship:** The second party will assist/guide the students for setting their own start ups and further will help them to be entrepreneur in their respective areas.

- 2.10 There is no financial commitment on the part of the **Institute of Mass Communication & Media Technology, Kurukshetra University Kurukshetra**, the First Party, to take up any activity mentioned in the MoU. If there is any financial consideration, it will be dealt separately.

### **CLAUSE 3 INTELLECTUAL PROPERTY**

- 3.1 Nothing contained in this MOU shall, by express grant, implication, Estoppel or otherwise, create in either Party any right, title, interest, or license in or to the intellectual property (including but not limited to know-how, inventions, patents, copy rights and designs) of the other Party.

### **CLAUSE 4 VALIDITY**

- 4.1 This Agreement will be valid initially for a period of 3 years. It can be extended further with mutual consent.
- 4.2 Both Parties may terminate this MOU upon 30 calendar days' notice in writing. In the event of Termination, both parties have to discharge their existing obligations

### **CLAUSE 5 RELATIONSHIP BETWEEN THE PARTIES**

- 5.1 It is expressly agreed that **First Party** and **Second Party** are acting under this MOU as independent entities, and the relationship established under this MOU shall not be construed as a partnership. Neither Party is authorized to use the other Party's name in any way, to make any representations or create any obligation or liability, expressed or implied, on behalf of the other Party, without the prior written consent of the other Party. Neither Party shall have, nor represent itself as having, any authority under the terms of this MOU to make agreements of any kind in the name of or binding upon the other Party, to pledge the other Party's credit, or to extend credit on behalf of the other Party.



- (vii) Research and Joint Consultancy Research Work;

## 2. Student Exchange:

Student Exchange activities (for Post Graduate & Doctoral Students) cover visits to either institution for any of the following purposes:

- (i) Participation in Research & Teaching programme;
- (ii) Students exchange activities;
- (iii) Visit of K.U. Students & Research Scholars at MGI, Mauritius and vice-versa;
- (iv) Exchange of relevant Academic Materials will be carried out subject to the mutual agreement of both institutions;
- (v) Visit of K.U. Delegation at MGI, Mauritius and vice-versa.

### ARTICLE-III

- (i) The implementation of cooperation based on this MoU shall be dealt with between the relevant Faculties and Divisions/Departments of both the institutions;
- (ii) Wherever necessary, a specific plan shall be worked out for each activity setting forth detailed arrangements for collaboration;
- (iii) Such plans shall be subject to the approval of the appropriate authorities of each institution;
- (iv) To facilitate the development of such plans, each institution shall nominate a member of its staff to coordinate activities arising under this MoU.

#### **ARTICLE-IV**

- (i) Both institutions agree and undertake to keep confidential at all times any information and/or data that may be exchanged, acquired and/or shared in connection with the area of cooperation as mentioned above unless otherwise the same information already exists in public domain.
- (ii) This Memorandum of Understanding may be amended by mutual consent of parties and any amendment shall enter in force upon signature by both parties.
- (iii) Both Parties shall endeavour to amicably settle any dispute which may arise during the execution of this Memorandum of Understanding.

#### **ARTICLE-V**

Ownership of any findings of any joint research shall be vested in both institutions on this MoU and any publication regarding the same shall only be possible after prior approval from both institutions.

#### **ARTICLE-VI**

The MoU shall remain in force for a period of 3 (Three) years commencing from the date of signing and may be reviewed by mutual consent by serving 3 (Three) months written notice to the other institution. Upon renewal, both institutions shall select either to proceed with the existing or new terms of understanding.

#### **ARTICLE-VII**

Both KUK and MGI reserve the right to terminate this MoU by either institution giving 3 (Three) months written notice to the other. Where such termination occurs, the provisions of this MoU shall continue to apply to ongoing activities until their completion.

#### **ARTICLE-VIII**

Participating staff and students involved in any activities under this MoU must adhere to the law of the country and the rules and regulations of the host institutions.

**ARTICLE-IX**

KUK and MGI welcome the establishment of this MoU for cooperation and jointly agree to the provisions as set out above. There will be two copies of this MoU equally valid, one for each institution, effective from the date of its signing.





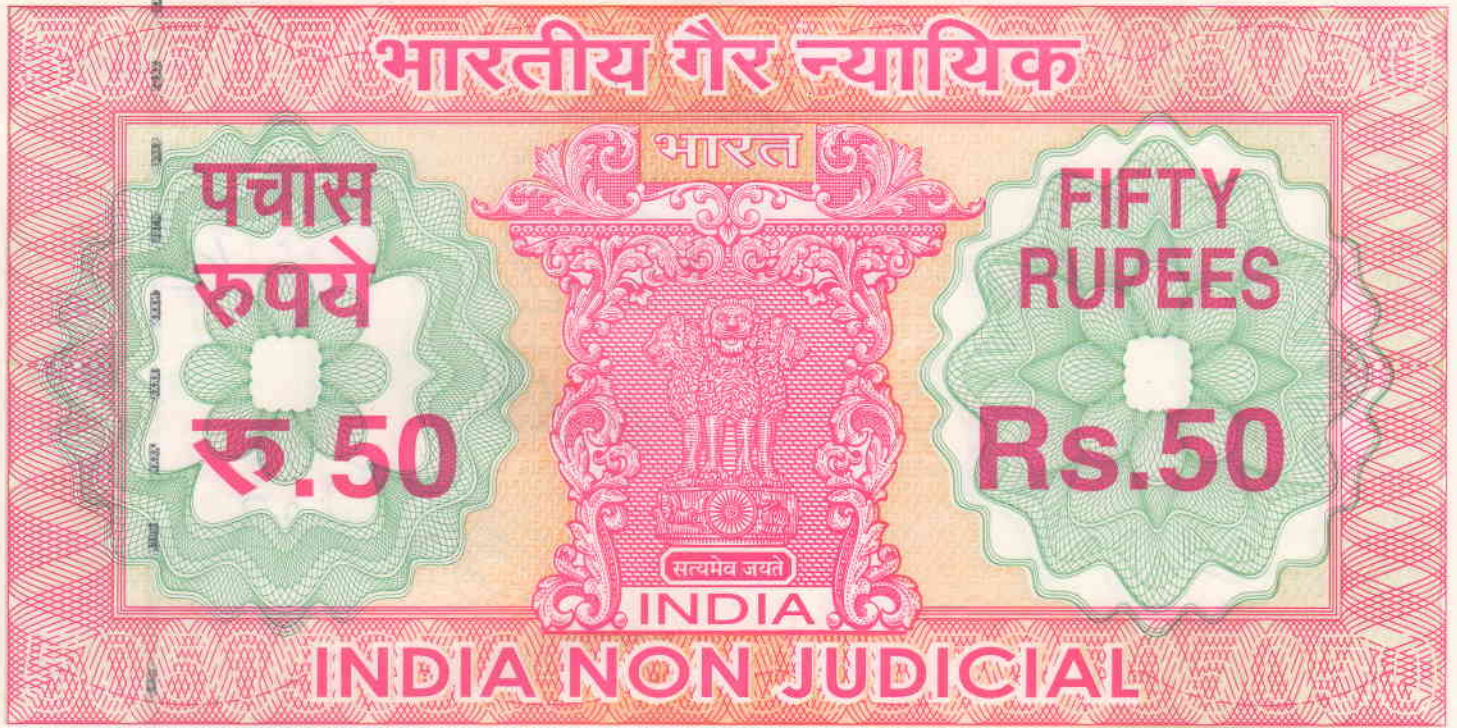

**WHEREAS**

The University has established a Corporate Resource Centre (CRC) under KURPS to build and promote industry-academia interface, with a focus on enhancing employability skills and employment outcomes of students graduating from the University and its affiliated colleges. KURPS has collaborated with Medha for strengthening the CRC as its "Knowledge & Capacity Building" partner.

This MOU defines and details the general framework of the collaboration as under:

**1. GENERAL PROVISIONS**

## 1.2 RELATION BETWEEN THE PARTIES

Nothing contained herein shall be construed as establishing the relation of purchaser and seller as between the first and second party. The second party, subject to this MOU, shall have complete charge of personnel implementing the Project and shall be fully responsible for the task completed by them.

## 1.3 GOVERNING LAW & JURISDICTION

This MOU, its meaning and interpretation, and the relation between the parties shall be governed by the laws applicable in India and they only shall have exclusive Jurisdiction over matters relating to or arising from this MOU.

## 1.4 LANGUAGE

This MOU has been executed in English language, which shall be the binding and controlling language for all matters relating to the meaning of interpretation of this MOU.

## 1.5 LOCATION

The matter i.e. Project implementation arising under this MOU shall be performed by the second party from its head offices at Lucknow and/or its nearest regional office, in addition to the Centre at the University as agreed upon by the first party.

## 1.6 AUTHORISED REPRESENTATIVES

Any action required or permitted to be taken and any document required or permitted to be executed under this MOU may be taken or executed

(a) On behalf of the first party, by the Chairman, BOG, KURPS, Kurukshetra, or his/her designated representative.

(b) On behalf of the second party, by the Executive Director, Medha Learning Foundation, or his/her designated representative.

## 2. COMMENCEMENT, COMPLETION, MODIFICATION AND TERMINATION OF THIS MOU

2.1 This MOU shall come into force from the date of signing, or other earlier date that is mutually agreed by the two parties.

2.2 Modification of the terms and conditions of this MOU, including the modification of the Project may be made at the time of annual review, with mutual agreement between the parties.

2.3 The MOU shall be effective for a period of three years, but KURPS will review/renew/modify (if needed) the MOU annually, based on the project outputs/outcomes.

The role and obligation of Medha and the University will be as under:

3. ROLE & OBLIGATION OF THE SECOND PARTY "MEDHA" UNDER THE COLLABORATION

- 3.1 Medha shall support the University team in developing employability training modules, piloting the modules with students, Training of Trainers of the faculty appointed by the University for employability training, building industry interface for greater engagement, managing the training & placement information system and mainstreaming employability training into University education.
- 3.2 Medha shall provide its employability (training) bootcamps' curriculum & pedagogy expertise to the University – focusing on Life skills, Digital literacy, Communication skills and Job readiness.
- 3.3 Medha shall also deliver the employability (training) bootcamps in the pilot stage through its own Trainers to selected students registered at the CRC. The ultimate goal of direct delivery shall be to build the capacities of the Centre to train the student using its own trainers/faculty members.
- 3.4 Medha shall also bring its expertise pertaining to career services, viz. skill assessment, industry workshops, internships & placement drives, alumni engagement etc. to the Centre under the Project.
- 3.5 Medha shall provide Training of Trainers & capacity building support to trainers/faculty nominated by the Centre for delivering employability training, placement and other career services to the students. Medha shall support the University in creating necessary systems & processes for allocation/empanelment/appointment of trainers and other resources required at the Centre.
- 3.6 Medha shall work with the University during the Project period for mainstreaming employability training in the University/college education.
- 3.7 Medha shall prepare a detailed workplan for Programme Implementation in consultation with the Centre and shall follow the same once approved by the University.
- 3.8 Medha shall abide by all the rules and regulations of the University in the functioning of Centre at the University.
- 3.9 Medha shall furnish all relevant information, including the workplan, progress reports and impact reports if any corresponding to the Project, to the University as and when required or demanded by the latter.

3.10 Medha shall not charge any service fee from the CRC for the implementation of the Project. However, the University/Centre shall cover the associated overhead costs under the Project viz. workstation for Medha personnel, travel & accommodation of trainers, engagement of external experts, printing & stationery, training materials & equipment and other costs associated with organizing industry events etc. in the implementation of the Programme. Such arrangements shall be made directly by the University/Centre and no payments shall be made to Medha or any of its personnel engaged directly/indirectly in the Programme.

#### 4. ROLE & OBLIGATION OF THE FIRST PARTY "KURPS" UNDER THE COLLABORATION



- 4.1 The University shall provide necessary infrastructure at the CRC, for the implementation of various activities under the Programme.
- 4.2 The University shall implement a central MIS for managing Training & Placement of its students through the CRC.
- 4.3 The University shall make necessary arrangements to implement the Programme on a sustainable basis, through allocation/empanelment/appointment of trainers and other resources required at the CRC.
- 4.4 The University shall seek recommendation from Medha/CRC for mainstreaming employability training in the University/college education.
- 4.5 The University shall nominate a single point of contact to facilitate and troubleshoot the Project at the University.
- 4.6 The University shall ensure full support and cooperation to Medha in all aspects of the Project implementation.

#### 5. REPORTING OBLIGATION

The **Second Party** shall submit to the **First Party** reports and documents as may be specified and at such frequency as may be agreed upon between the two parties. The **Second Party** will collect and maintain the records of students served from the Centre and shall monitor and report their progress to the **First Party**.

#### 6. ARBITRATION

Both the parties shall use all reasonable endeavors to resolve or settle the disputes through mutual negotiation and discussions in connection with this MOU or the interpretation thereof. Any and all disputes, controversies and conflicts ("**Disputes**") arising out of this MOU between the parties or arising out of or relating to or in connection with this MOU or the performance or non-performance of the rights and obligations set forth herein or the breach, termination,

invalidity or interpretation thereof which cannot be settled or resolve amicably shall be referred for arbitration to a suitable committee at Kurukshetra University, Kurukshetra. The arbitral award shall be in writing and shall be final and binding on each party and shall be enforceable in any court of competent jurisdiction. None of the parties shall be entitled to commence or maintain any action in a court of law upon any Dispute arising out of or relating to or in connection with this MOU.

7. CONSEQUENCE OF BREACH AND PENALTIES

- a. It shall be obligatory on part of either party to ensure timely Project implementation and facilitation as per the pre-approved workplan as agreed upon in the MoU.
- b. In the event of breach of any term or conditions of this agreement, either party shall have the right to terminate the agreement and recover costs incurred that are associated with the project.

## DECLARATIONS

### FIRST.- KURUKSHETRA UNIVERSITY :

1. That, its legal address is Kurukshetra Haryana - 136119
2. That its participation in the execution of this agreement will be through the Department of Physical Education, Kurukshetra University. .

### SECOND.- Physical Education Foundation of India declares:

1. Is a NGO registered vide Number 4154 on Page No. 48 to 67 on this date 28/8/2008 for the promotion of Physical Education & Sports in India under the Trust Registration Act (Government of India) with registration Number 4154 on Dated 28th August 2013.
2. Its aim is to get Indian Healthy Fit and free from Diseases.
3. Mr. Piyush Kumar Jain as Secretary, authorized for the legal work and signing of MOU for the foundation up to 29th August 2025 and its legal residence is located at 7/26, KSK, Lower Ground Floor, Ansari Road, Daryaganj, New Delhi - 110002

### The Agreement will be governed by the following clauses:

**FIRST.- PURPOSE.-** The present agreement aims to encourage and establish a collaboration network to generate knowledge exchange between the two signatory institutions in research, popularization and teaching in the areas of Physical Education, Sport, Recreation and Physical Activity.

**SECOND.- SCOPE.-** For the achievement of the subject of this agreement shall be carried out the following activities:

1. Generate popularization products between the institutions, which benefit the academic programs that drive this agreement.
2. Promote short and long duration mobility academic exchange of teacher-researchers in teaching presence (face-to-face) or virtual manner: subjects, modules, units or specific topics, according to the possibilities of each academic institution's resource exchange policies.
3. Promote students' academic mobility to study a semester, specific subjects, or to perform social service or professional practice in institutions or companies authorized by the receiving institution.
4. Negotiate for the development of research and the dissemination of the same in international and national organizations.
5. Promote lecturers exchange in academic events programmed by the signatory institutions, as well as, the accomplishment of seminars and training courses, either personally or through videoconferences.

**THIRD.-WORK PROGRAMMES.-**The following priority areas of work has been established:

**Teaching.** The pooling of specialist teachers in presence and/or virtual form of Physical Education, Recreation, Sport and Physical Activities destined to the following topics: theories and currents of PE, didactics, exercise physiology, sports training, disability, gymnastics, theory 's game, sports, activities in the natural environment, camps and research seminars.

**Research.** Four priority lines of research production will be established:

1. Physical Education, Body, Culture and Activity. Senses and culture in India.
2. Teaching Physical Education. Game, gymnastics, physical activity, leisure, recreation, and sport, practices and speeches of the body in physical education.
3. Sport and Society. The Hindu and Mexican citizenship and sport: institutions, social organizations, new sports activities, sports industries, professional sports, media and sports, etc.
4. Education, disability and inclusion. Vocational training, motor skills development, special didactics and outstanding skills.

**FOURTH - COMMITMENTS OF THE PARTIES.-** The signatory parties of the present document will collaborate at all times, in accordance with the principles of good faith and effectiveness, to ensure the proper execution of the agreement and to encourage and promote the cultural, scientific, academic and technological development of the academic programs of the signatory institutions.

**FIFTH - COMMISSION OF AGREEMENTS.-** A Monitoring Committee will be created for the implementation, control and monitoring of the activities foreseen in this Agreement; by the Chairperson, Department of Physical Education and Physical Education Foundation of India, Secretary Piyush Jain; both parties will be responsible for the following functions:

- » To plan, promote, monitor and evaluate programs and actions to be undertaken under this Agreement.
- » To establish the internal rules of the Monitoring Committee, in accordance with the Statutes of the signatories.
- » To create subcommittees that were relevant to the development of the various programs of action.

**SIXTH - VALIDITY -** This instrument will be valid for three years from the date of its signature. However, the parties may terminate early, for which the interested party shall notify the other party in writing, within thirty days of anticipation, on the understanding that the parties undertake to comply with all the obligations agreed that are pending completion and which are in development.

**SEVENTH- MODIFICATIONS.-** The present Agreement may be amended or supplemented by agreement of the parties provided they are in writing. Modifications or additions oblige signatories from the date of signature, on the understanding that they will have the sole purpose of improving and contributing to the fulfillment of the purpose of this agreement.

**EIGHTH - INTERPRETATION.-** The conditions of this Agreement constitute the entirety of the agreement between the parties, and represent the complete integration and final expression of the agreement between them regarding the matter stated therein.

It is understood that the implementation of this Memorandum of Understanding will commence on the day of signature, and will continue thereafter for five years, subject to revision or modification from time to time by mutual agreement. For renewal, the representative from both institutions will discuss the terms at least six months prior to the natural termination of the current Memorandum of Understanding. The conflict of interest, if any, can be decided by the mutual consultations.



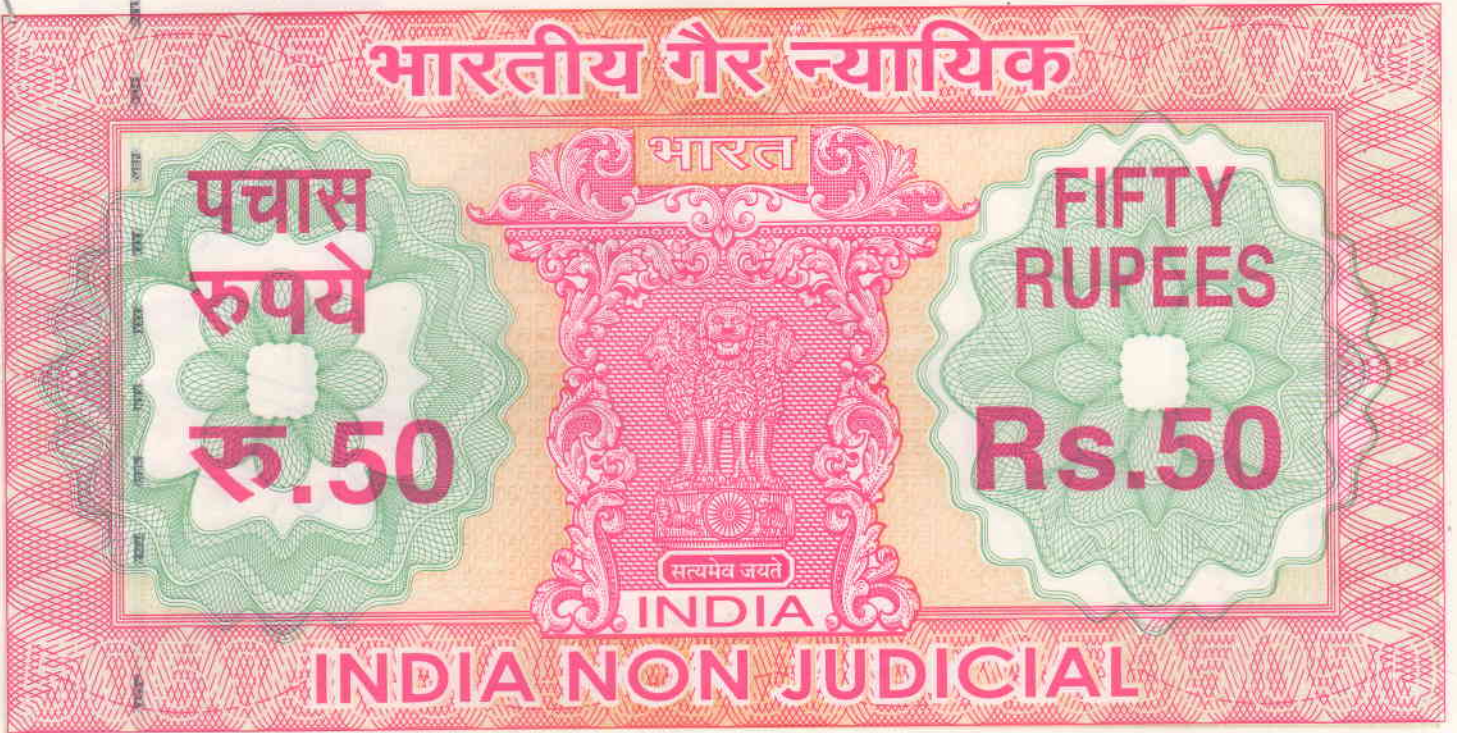

NOW THIS MEMORANDUM OF UNDERSTANDING WITNESSETH and it is hereby agreed and declared between the Parties as follows:

1. Each Party represents and warrants to the other Party that:
  - 1.1 it has the power and authority to execute and deliver this MOU, and carry out its obligations and exercise its rights hereunder, and the consummation of this understanding does not derogate or conflict with its bye-laws or memorandum of association or any other contract or understanding it has with any other person;
  - 1.2 the execution and delivery of this MOU and the promises, agreements or undertakings under this MOU do not violate any (i) law, rule, regulation or order applicable to it; or (ii) agreement or any other instrument which it has executed with any other person(s); or (iii) its bye-laws or memorandum of association or such other document of a similar nature;
  - 1.3 the information and details (both oral and written) provided by it for the purposes of this MOU and the understanding contemplated hereunder are true and correct and not misleading in any manner whatsoever.
2. By executing this MOU, the Parties hereby agree and acknowledge that the Parties shall make best efforts to do and complete a number of the following:
  - 2.1 provide opportunities to all media students enrolled in the University through a process satisfactory to the University ("Student Journalists");
  - 2.2 promote student journalism by means of extending paid, round-the-year, remote internships to the Student Journalists;
  - 2.3 provide on-ground news reporting and news feature production experience to Student Journalists;
  - 2.4 connect Student Journalists and journalism faculties across India;
  - 2.5 assist Student Journalists in creating a relevant portfolio;
  - 2.6 aim to create the largest network of on-ground student reporters in India;
  - 2.7 aim to extend, or facilitate the extension of, INR 300 (Indian Rupees five hundred) for every original segment uploaded on any of Newshound's platforms or in relation to any story chosen and being worked on by a Student Journalist (the mode and terms whereof shall be mutually discussed and decided between Newshound and the relevant Student Journalist);
  - 2.8 assist Student Journalists network with veteran journalists from the journalism profession, along with other relevant industry professionals;
  - 2.9 network with prospective donors to assist student journalism and further the objects of the charter documents of Newshound;



- 2.10 bringing together contributors, collaborators and mentors to join and provide facilities and services to mentor Student Journalists
3. The areas of cooperation may include, subject to mutual consent between the Parties, any other desirable and feasible activities that would further the common goal of providing facilitating the first wave of student journalists in India, including but not limited to, rendering further requisite financial, infrastructural and educational assistance and support to the Student Journalists.
4. The Parties anticipate that a number of the activities and initiatives listed above shall occur during the term and tenure of this MOU. However, provided neither Party commits or omits to do any actions in derogation of the terms of this MOU, neither Party is or shall be deemed to be obligated to agree to the completion of any minimum number of activities or initiatives set out above.
5. The Parties hereby agree and acknowledge that, in order to achieve the objectives and complete the actions set out in this MOU, and in addition to the activities and initiatives set out above in Clauses 2 of this MOU, the Parties shall, with mutual written consent, appoint not more than 2 (two) persons (unless otherwise agreed between the Parties), each of them being students of the University, each of whom shall individually be referred to as a "Newshound Student Facilitator". It is further agreed that such Newshound Student Facilitator shall act as the point of contact between Newshound, the Student Journalists and any other students enrolled in the University. Such Newshound Student Facilitator shall also, at regular intervals, update Newshound of the progress of the understanding and actions contemplated under this MOU. Such Newshound Student Facilitator shall take all actions relevant and necessary to ensure that Newshound and/or the Student Journalists are not precluded, prohibited or stopped, in any manner, from having access to and utilizing the media and journalism facilities of the University in order to give effect to and complete, in a satisfactory manner, the actions contemplated hereunder.
6. This MOU shall come into effect on the date of its execution and shall remain in full force and effect until such time as the Parties may mutually agree, in writing, or until such time as the termination hereof. It is also agreed between the Parties that this MOU can be terminated by either Party, by giving 1 (one) week's notice to the other Party, accompanied with reasons in writing, which reasons shall be reasonable, fair and non-discriminatory.
7. Each of the Parties acknowledges that the Parties have entered into this MOU on the basis of the representations made by the other Party. In the event any Party becomes aware of any fact, matter or circumstance (whether existing on or before the date of this MOU or arising afterwards) which would cause any of the representations and warranties given by them, to become untrue or inaccurate or misleading in any material respect, it shall duly inform the other Party of the same, in writing.
8. Both the parties can use logos of each other to exhibit the list of partners. No other use of logo will be allowed.

9. The reports by the students of the Institute shall not contain anything defamatory against the University/Institute/State Government/Central Government. IMC&MT will devise a mechanism to filter and route students' submission to Newshound. Newshound will not publish any report of students which are not routed through the Institute.
  10. It is clearly agreed and understood by and between the Parties hereto that this understanding does not amount to a partnership or association of persons and each Party will carry out its own actions independently. It is expressly agreed that neither Party shall act as a deemed agent or principal of the other Party.
  11. If any dispute or difference of any kind whatsoever arises between the Parties in connection with, or out of, this MOU, the Parties shall attempt to amicably resolve such disputes. If the dispute cannot be settled within 30 (thirty) days by mutual discussion, the Parties agree that the courts of Kurukshetra, India, shall have the jurisdiction to try and entertain any suit, claim or action arising out of this understanding.
  12. Any provision of this MOU which is invalid or unenforceable shall be ineffective to the extent of such invalidity or unenforceability, without affecting, in any manner, the remaining provisions hereof.
  13. Each Party shall bear and pay its own costs and fees in relation to the execution of this MOU.
  14. Each of the Parties hereto shall do and execute all further acts, deeds, matters and things as may reasonably be required of them to carry out and implement the terms and provisions of this MOU.

  17. There is no financial liability on the part of Institute of Mass Communication and Media Technology, Kurukshetra University, Kurukshetra to take up any activity mentioned in the MoU. If there is any financial consideration, it will be dealt separately.

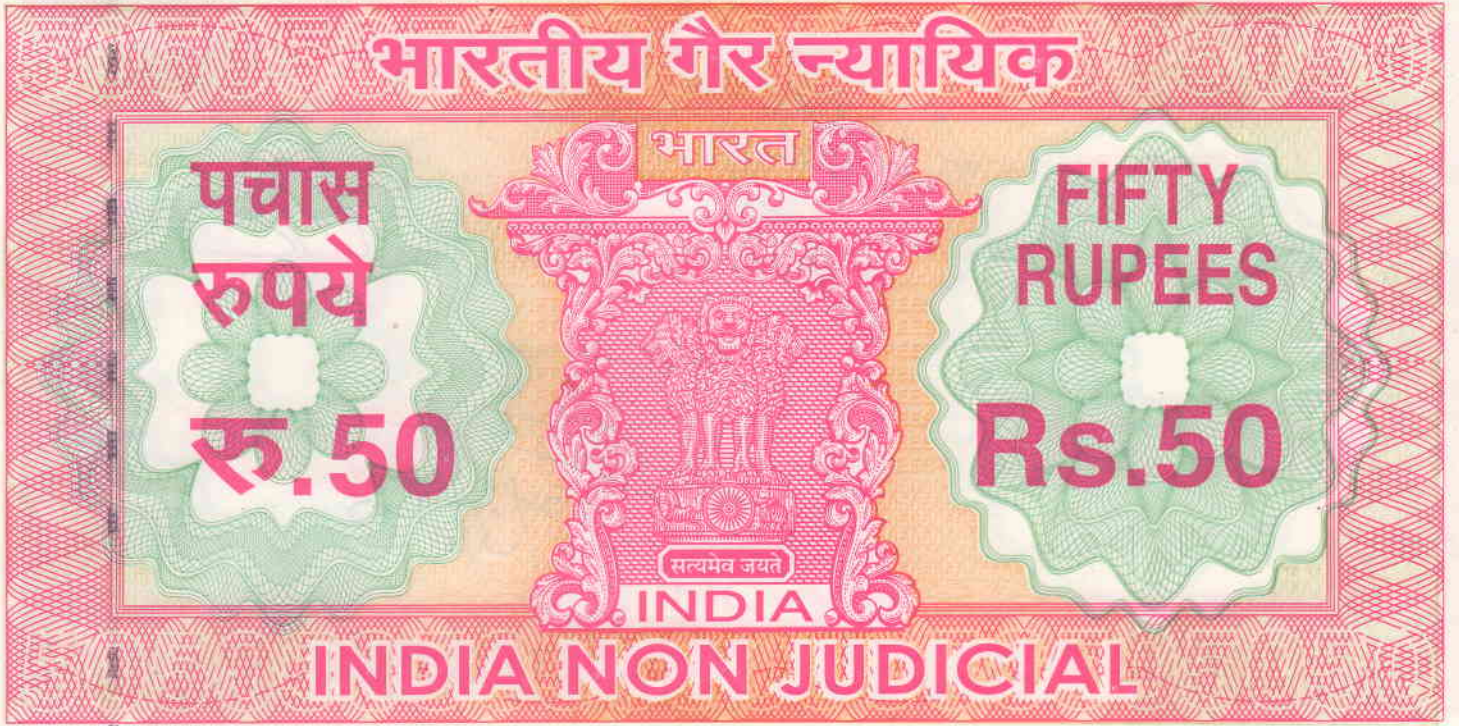

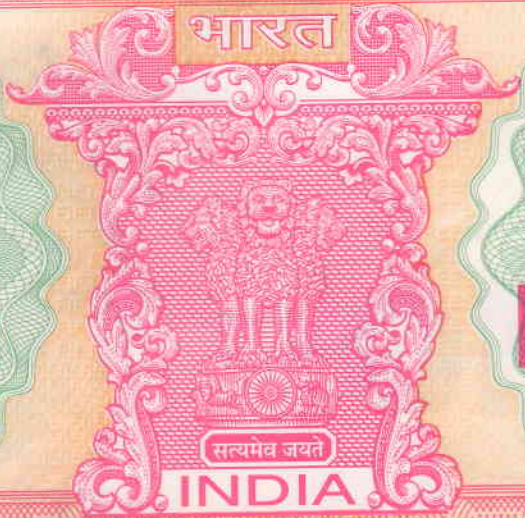

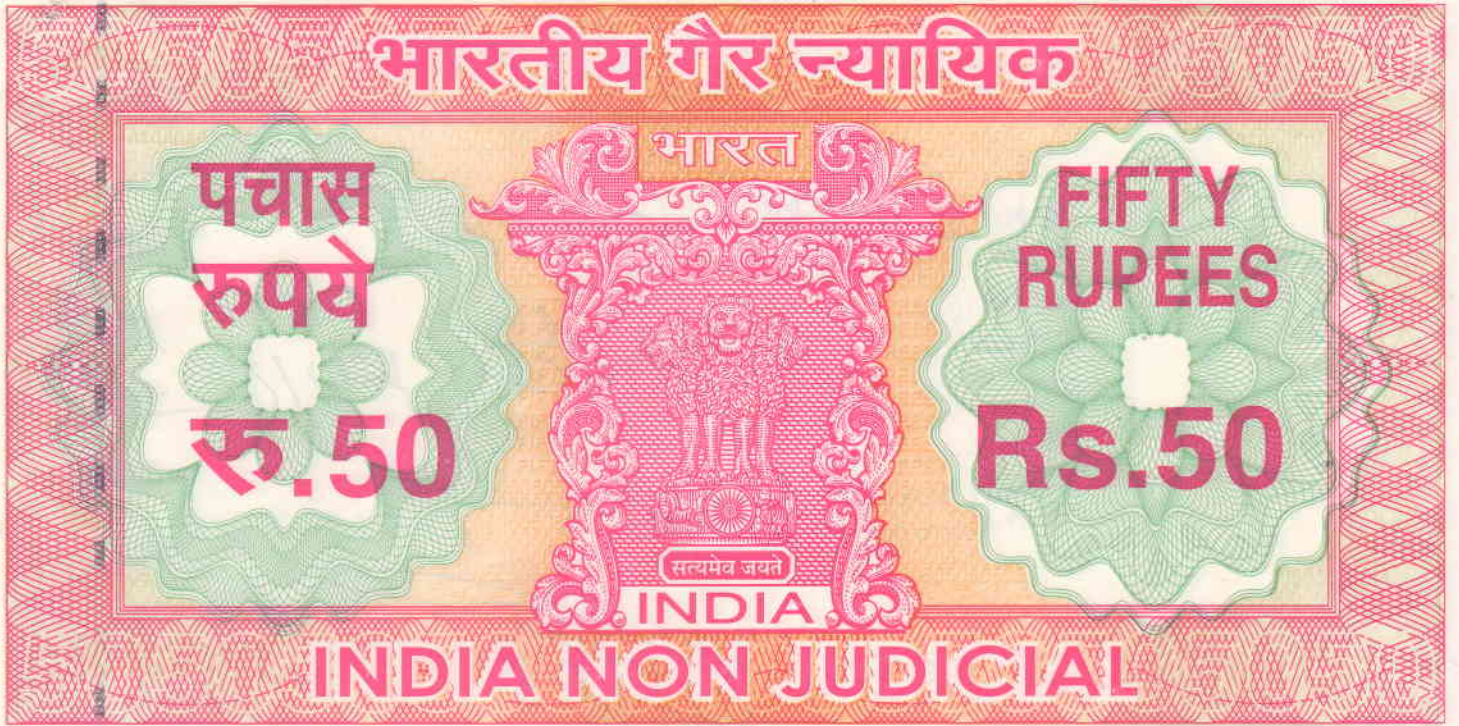

### 1.3 Governing Law & Jurisdiction

This MOU, its meaning and interpretation, and the relation between the parties shall be governed by the laws applicable in India and they only shall have exclusive Jurisdiction over matters relating to or arising from this MOU.

2. Customized training programs designed for teaching faculty, non teaching staff, students of the university and colleges affiliated to Kurukshetra University, different stake holders and grass root functionaries.
3. Short-term visiting faculty program.
4. Joint Research and Development Programs and Publication Activities.
5. Value added courses for the female students of the university.

6. Internship and Training.
7. Other programs of mutual interest.

#### 4. Role & Obligation of the First Party "WSRC" under the Collaboration

- 4.1 The University shall provide necessary infrastructure for the implementation of various activities under the Programme.
- 4.2 The University shall nominate a single point of contact to facilitate and troubleshoot the programme at the University.
- 4.3 The University shall ensure full support and cooperation to Stree Shakti – The Parallel Force in all aspects of the programme implementation.
- 4.4 There with no financial liability on the part of the Kurukshetra University, Kurukshetra, for implementation of the programmes.

#### 5. Arbitration

Both the parties shall use all reasonable endeavors to resolve or settle the disputes through mutual negotiation and discussions in connection with this MOU or the interpretation thereof. Any and all disputes, controversies and conflicts ("**Disputes**") arising out of this MOU between the parties or arising out of or relating to or in connection with this MOU or the performance or non-performance of the rights and obligations set forth herein or the breach, termination, invalidity or interpretation thereof which cannot be settled or resolve amicably shall be referred for arbitration to a committee constituted at Kurukshetra University, Kurukshetra. The arbitral award shall be in writing and shall be final and binding on each party and shall be enforceable in the courts of Kurukshetra or courts having jurisdiction in Kurukshetra. None of the parties shall be entitled to commence or maintain any action in a court of law upon any Dispute arising out of or relating to or in connection with this MOU.

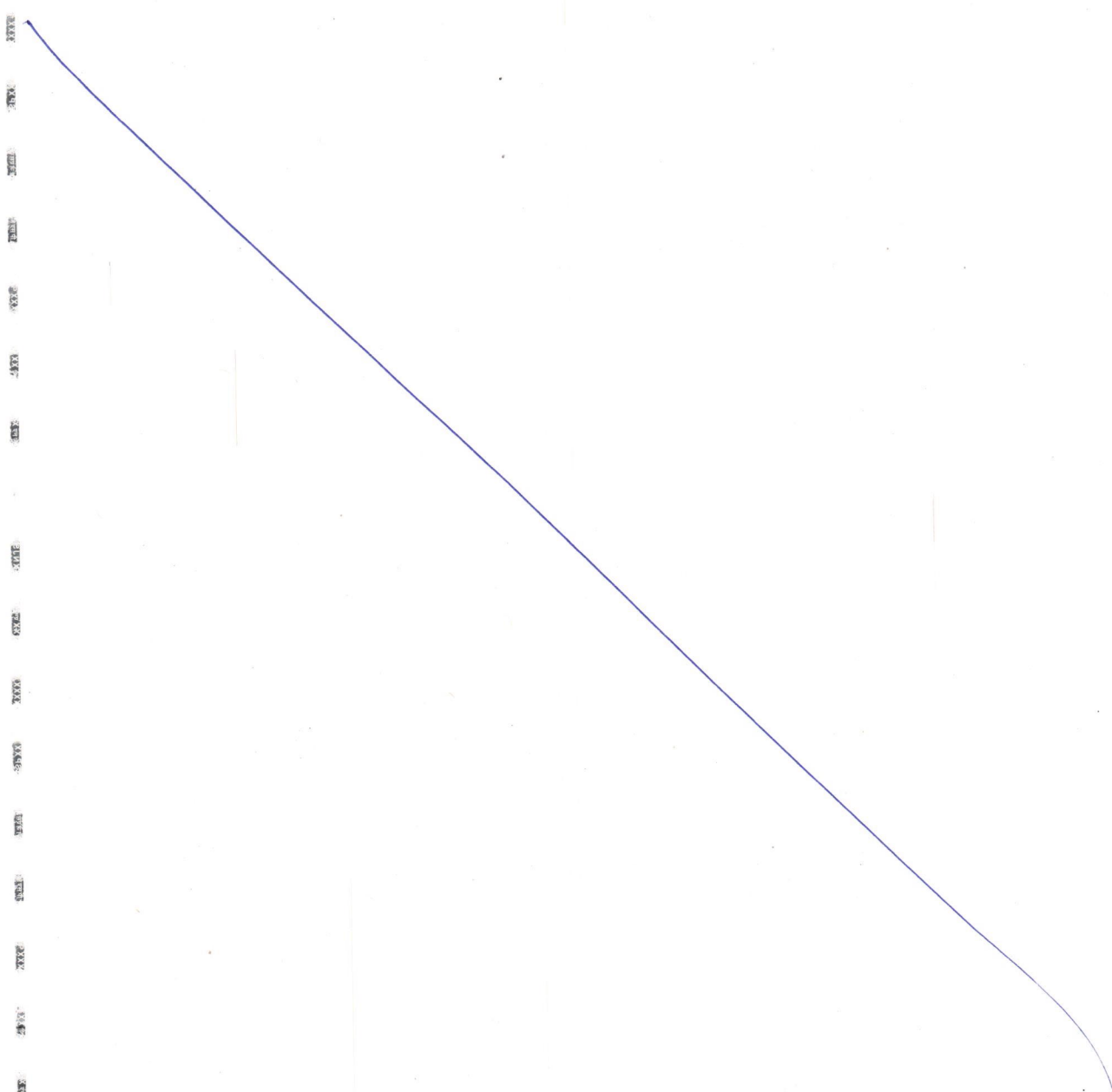



### BETWEEN

**University Institute of Engineering and Technology, Kurukshetra University, Kurukshetra (Haryana), the First Party** represented herein by its **Director** (hereinafter referred to as '**First Party**', the institution which expression, unless excluded by or repugnant to the subject or context shall include its successors - in-office, administrators and assigns).

### AND

**Centre for Development of Advanced Computing(C-DAC), Plot No. A-34, Industrial Area, Phase-VIII, Mohali-160071(Punjab), having its registered office at Pune (Maharashtra), the second party** and represented herein by its **Executive Director**, (hereinafter referred to as "**Second Party**", a Scientific Society of Ministry of Electronics and Information Technology, Government of India, of which expression, unless excluded by or repugnant to the subject or context shall include its successors-in-office, administrators and assigns).

(First Party and Second Party are hereinafter jointly referred to as 'Parties' and individually as 'Party')

### WHEREAS:

- A) First Party is a Higher Educational Institution named:
- **University Institute of Engineering and Technology, Kurukshetra University, Kurukshetra (Haryana)**
- B) First Party & Second Party believe that collaboration and co-operation between themselves will promote more effective use of each of their resources, and provide each of them with enhanced opportunities.





- C) The Parties intend to cooperate and focus their efforts on cooperation within area of Skill Based Training, Education and Research.
- D) Both Parties, being legal entities in themselves desire to sign this MOU for advancing their mutual interests.
- E) **Centre for Development of Advanced Computing(C-DAC) Mohali**, the Second Party, a Scientific Society of Ministry of Electronics and Information Technology, Government of India, is engaged in Skill Development Training, Education and R&D Services in the fields of Information Technology and Electronics and related fields. The second party is engaged in design and development of world class Electronic and IT solutions for economic and human advancement. It caters to the training, consultancy, design and product development needs of Electronics and Information Technology industry and its allied sectors. In the Education and training domain, it offers M.E. Programmes in VLSI Design, Electronic Product Design and Technology (EPDT), Embedded Systems and IT (Part-Time). The major thrust areas of the Centre include training and R&D in;
- Multilingual and Heritage Computing,
  - Software Technologies including e-governance solutions, e-learning technologies, open source software, etc.
  - Professional Electronics covering electronic devices and embedded systems, etc.
  - Information and Cyber Security including intrusion detection and prevention, malware analysis, cyber forensics, network security, etc.
  - Health Informatics including medical electronics, hospital information systems, electronic medical records, telemedicine, ubiquitous computing, etc.

**NOW THEREFORE, IN CONSIDERATION OF THE MUTUAL PROMISES SET FORTH IN THIS MOU, THE PARTIES HERETO AGREE AS FOLLOWS:**

**CLAUSE 1 CO-OPERATION**

- 1.1 Both Parties are united by common interests and objectives and they shall



establish channels of communication and co-operation that will promote and advance their respective operations within the Institutions and its related wings. The Parties shall keep each other informed of potential opportunities and shall share all information that may be relevant to secure additional opportunities for one another.

- 1.2 First Party and Second Party's co-operation will facilitate effective utilization of the intellectual capabilities of the faculty of First Party providing significant inputs to them in developing suitable teaching / training systems, keeping in mind the needs of the industry, the Second Party.
- 1.3 The general terms of co-operation shall be governed by this MOU. The Parties shall cooperate with each other and shall, as promptly as is reasonably practical, enter into all relevant agreements, deeds and documents (the 'Definitive Documents') as may be required to give effect to the actions contemplated in terms of this MOU. The term of Definitive Documents shall be mutually decided between the Parties. Along with the Definitive Documents, this MOU shall represent the entire understanding as to the subject matter hereof and shall supersede any prior understanding between the Parties on the subject matter hereof. The MOU may be done for 5 years duration.

## **CLAUSE 2 SCOPE OF THE MoU**

- 2.1 The budding graduates from the institutions could play a key role in technological up-gradation, innovation and competitiveness of an industry. Both parties believe that close co-operation between the two would be of major benefit to the student community to enhance their skills and knowledge.
- 2.2 **Curriculum Design:** Second Party will give valuable inputs to the First Party in teaching / training methodology and suitably suggest on

customizing the curriculum so that the students fit into the industrial scenario meaningfully.

- 2.3 **Industrial Training & Visits:** Industry and Institution interaction will give an insight into the latest developments / requirements of the industries; the Second Party is to permit the Faculty and Students of the First Party to visit its Centre and also involve in Industrial Training Programs for the First Party. The industrial training and exposure provided to students and faculty through this association will build confidence and prepare the students to have a smooth transition from academic to working career. The Second Party will provide its Labs / Workshops / Industrial Sites for the hands-on training of the learners enrolled with the First Party. The Second Party shall offer a discount of 20% on the fee remitted by each student of its Summer training and Industrial training courses to the students enrolled with First Party and other Engineering / Technical departments of Kurukshetra University, for a batch of minimum 20 students.
- 2.4 **Internship and Placement of Students:** Second Party will actively engage to help the delivery of the Internship and placement of students of the First Party into internships/jobs, as per AICTE internship Policy. The Second Party will also register itself on AICTE Internship Policy Portal for disseminating the Internship opportunities available with them.
- 2.5 **Research and Development:** Both Parties have agreed to carry out the joint research activities in the fields of **Computer Science, Information Technology, Electronics and related technological field.**
- 2.6 **Skill Development Programs:** Second Party to train the students of First Party on the emerging technologies in order to bridge the skill gap and make them industry ready. The Second Party shall offer a discount of 20% on the fee remitted by each student of its Certificate and Diploma courses to the students enrolled with First Party, for a batch of minimum 20 students. Second party may also organize / conduct short term certificate / diploma courses at KUK campus on the mutual agreed subjects / topics, timing and financial terms decided as and when applicable.

- 2.7 **Guest Lectures:** Second Party to extend the necessary support to deliver guest lectures to the students of the First Party on the technology trends and in house requirements.
- 2.8 **Faculty Development Programs:** Second Party to train the Faculties of First Party for imparting industrial exposure/ training as per the industrial requirement considering the National Occupational Standards in concerned sectors, if available.
- 2.9 **Products/Solutions/Services:** Second Party has designed & developed various software solutions for institutions of higher education namely **eAkadmik-An integrated Academic ERP solution, eMulazim-Employee Management System, Cyber Security Technology solutions based on Honey pot technology**, etc. The Second Party is also engaged in design and development of customized software solutions for web and mobile platform using latest technologies such as Artificial Intelligence, BigData, & IoT. The First Party agrees to evaluate and implement the products/solutions of the Second Party as per the requirement and Second Party agrees to implement the products/solutions on mutually agreed techno-financial terms.
- 2.10 **Entrepreneurship Development/Innovation/Hackathon:** The Second Party is actively involved in organizing Entrepreneurship Awareness Camps and Technology Based Entrepreneurship Development Programmes to make faculty and students aware of the various facets of Entrepreneurship. The Parties agrees to jointly organize Entrepreneurship Development Programmes, Start-Up Events, Innovation Competition, Idea Competition, Hackathon, etc. in order to inculcate a culture of product innovation, design thinking and a mindset of problem solving amongst students enrolled with the first party.
- 2.11 Both Parties to obtain all internal approvals, consents, permissions, and licenses of whatsoever nature required for offering the Programs on the terms specified herein



2.12 There is no direct financial obligation on either party unless specifically agreed to. The financial requirement of second party to take up any program mentioned in MoU would be dealt separately.

### **CLAUSE 3 INTELLECTUAL PROPERTY**

3.1 Nothing contained in this MOU shall, by express grant, implication, Estoppel or otherwise, create in either Party any right, title, interest, or license in or to the intellectual property (including but not limited to know-how, inventions, patents, copy rights and designs) of the other Party.

### **CLAUSE 4 VALIDITY**

4.1 This MOU will be valid initially for a duration of five years, which would be revised further for another term of five years based on mutual consent, until it is expressly terminated by either Party on mutually agreed terms, during which period **Centre for Development of Advanced Computing(C-DAC)**, the Second Party, as the case may be, will take effective steps for implementation of this MOU. Any act on the part of **Centre for Development of Advanced Computing(C-DAC)**, the Second Party after termination of this Agreement by way of communication, correspondence etc., shall not be construed as an extension of this MOU.

4.2 Both Parties may terminate this MOU by giving 30 calendar days' notice in writing. In the event of Termination, both the parties have to discharge their obligations.

### **CLAUSE 5 RELATIONSHIP BETWEEN THE PARTIES**

5.1 It is expressly agreed that **First Party** and **Second Party** are acting under this MOU as independent contractors, and the relationship established under this MOU shall not be construed as a partnership. Neither Party is authorized to use the other Party's name in any way, to make any representations or create any obligation or liability, expressed or implied, on behalf of the other Party.



Any divergence or difference derived from the interpretation or application of the MoU shall be resolved by arbitration between the parties as per the Arbitration Act, 1996. The place of the arbitration shall be at District Head Quarters of the first Party. This undertaking is to be construed in accordance with Indian Law with exclusive jurisdiction in the Courts of Kurukshetra.

## NON-BINDING STATEMENT OF SHARED GOALS

relationship. Neither party shall have the right, power, or authority to obligate or bind the other party in any manner whatsoever, without the other party's prior written consent.

**d. Expenses.** Microsoft and Customer agree that each party shall pay its own fees, costs and expenses, and those of its agents, independent contractors, and consultants, in connection with this Agreement.

**e. Disclaimer of Warranties.** Neither party makes any warranties. To the maximum extent permitted by law, each party and its respective affiliates, agents and representatives expressly disclaim all express, statutory and implied warranties.

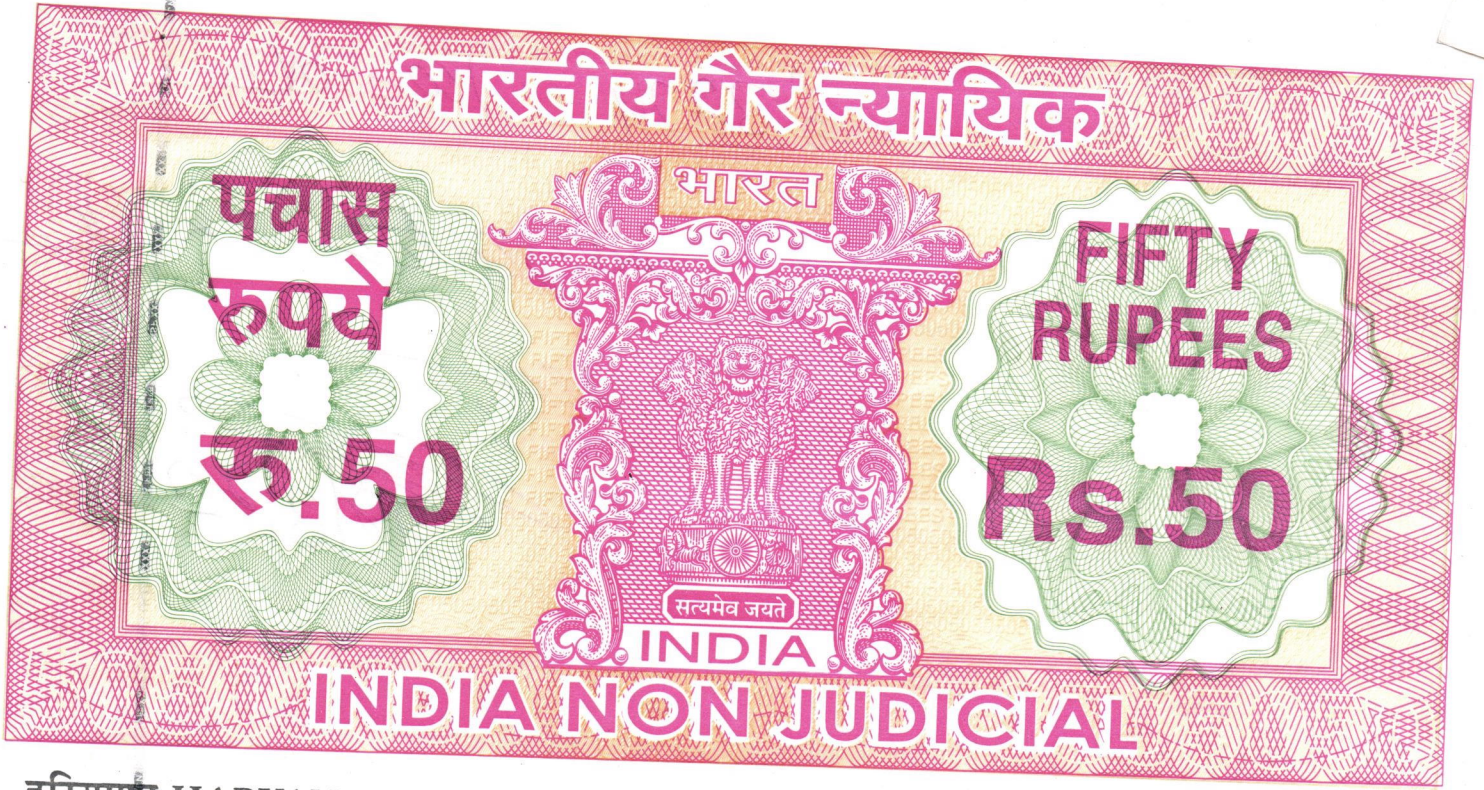

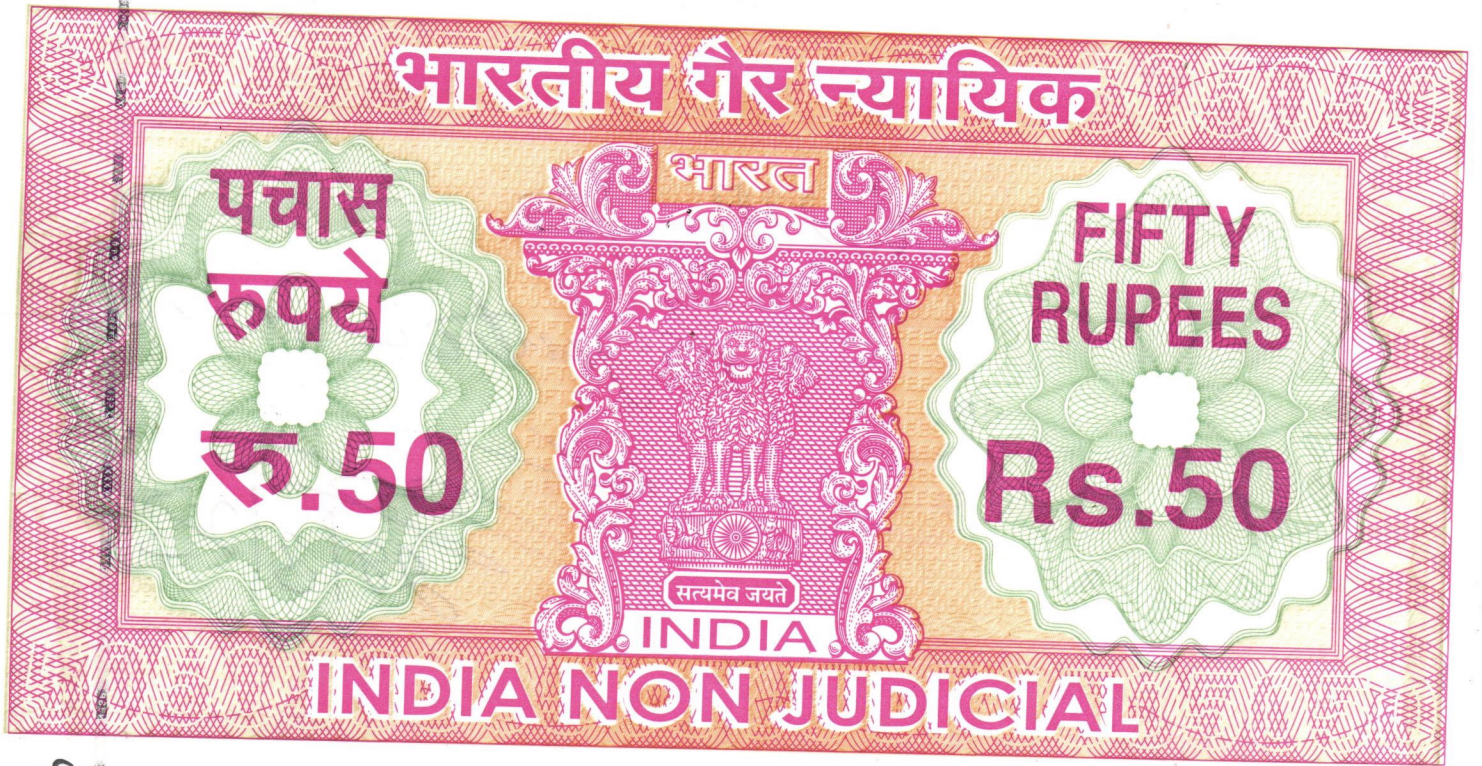

#### **CLAUSE 1 CO-OPERATION**

- 1.1 Both Parties are united by common interests and objectives, and they shall establish channels of communication and co-operation that will promote and advance their respective operations within the **Institution** and its related wings. 


subject matter hereof and shall supersede any prior understanding between the parties on the subject matter hereof.

## **CLAUSE 2 SCOPE OF THE MoU**

- 2.7 **Guest Lectures:** Second Party to extend the necessary support to deliver guest lectures to the students of the First Party on the technology trends and in house requirements.
- 2.8 **Faculty Development Programs:** Second Party to train the Faculties of First Party for imparting industrial exposure/ training as per the industrial requirement considering the National Occupational Standards in concerned sector, if available.
- 2.9 Both Parties to obtain all internal approvals, consents, permissions, and licenses of whatsoever nature required for offering the Programs on the terms specified herein.
- 2.10 There is no financial commitment on the part of the **University Institute of Engineering & Technology, Kurukshetra University, Kurukshetra**, the First Party to take up any program mentioned in the MoU. If there is any financial consideration, it will be dealt separately.
- 2.11 The name and insignia of K.U. cannot be used by the Second Party for any purposes except with the explicit permission of the First Party.
- 2.12 The institute/ university shall use all the new ways and means in this regard for the design and development of the RFID Tag & Antenna for Wavelinx, the second party at agreed shared cost basis which is mutually decided project to project.
- 2.13 The design/development charges of work to be paid by Wavelinx to the institute/university shall be negotiated on case to case basis on the basis of mutual agreement and shall be agreed between the parties to avoid any kind of dispute or differences. The institute/university shall not be entitled to any money against expenses etc in any manner, if the work has not been assigned to it by the Wavelinx through a written communication. - 2.16 That the institute/ university shall develop and test the antennas and will share the prototype of antennas exclusively with Wavelinx.
- 2.17 That the institute/ university shall modify the design of antenna without any extra cost, if the performance of antenna/tag is not found as per previously communicated design by Wavelinx and consumable including material will be borne by Wavelinx as per project required.
- 2.18 That the present agreement can be terminated by the parties at their will after giving 30 days notice in writing.
- 2.19 That the present agreement covers only RFID Antenna /Tag Design development job for the Wavelinx. No other business or fiduciary relationship between the parties shall be created.

### CLAUSE 3 INTELLECTUAL PROPERTY

- 3.1 Nothing contained in this MOU shall, by express grant, implication, Estoppel or otherwise, create in either Party any right, title, interest, or license in or to the intellectual property (including but not limited to know-how, inventions, patents, copy rights and designs) of the other Party.

### CLAUSE 4 VALIDITY

- 4.1 This Agreement will be valid until it is expressly terminated by either Party on mutually agreed terms, during which period **Wavelinx, D-22-B, DDA Flats, Behind Shivaji College, Raja Garden, New Delhi 110027**, the Second Party, as the case may be, will take effective steps for implementation of this MOU. Any act on the part of **Training Partner** or **Wavelinx**, the Second Party after termination of this Agreement by way of communication, correspondence etc., shall not be construed as an extension of this MOU.
- 4.2 Both Parties may terminate this MOU upon 30 calendar days' notice in writing. In the event of Termination, both parties have to discharge their obligations.
