- B) First Party & Second Party believe that collaboration and co-operation between themselves will promote more effective use of each of their resources, and provide each of them with enhanced opportunities.
- C) The Parties intent to cooperate and focus their efforts on cooperation within area of Subject Based Orientation, Education, Expert Lecture.
- D) The First and Second Party is engage in exchange of educational ideas, innovation and academic activities.

NOW THEREFORE, IN CONSIDERATION OF THE MUTUAL PROMISES SET FORTH IN THIS AOU, THE PARTIES HERETO AGREE AS FOLLOWS:


CLAUSE 1: CO-OPERATION

- 1.1 Both Parties are united by common interests and objectives, and they shall establish co-operation.
- 1.2 First Party and Second Party co-operation will facilitate effective utilization of the intellectual capabilities.
- 1.3 First Party and Second Party desire to establish academic collaboration to promote the institutional collaborations through this Agreement of Understanding (AoU) with a view of sharing a common interest to explore extend and strengthen the functional relationship including Academics, Study, Teaching and Research in social sciences. The parties shall co-operate with each other and shall as promptly as is responsibly practical, relevant agreement.

CLAUSE 2: SCOPE OF THE AoU

2.1 Collaboration in Academic Events: First and Second party shall collaborate in mutually agreeable events, teaching, training and research, wherever feasible. Such collaboration will be based on mutually agreeable terms and conditions specially agreed for each of the collaborative efforts;

2.2 Guest Lectures: First and Second Party to extend the necessary support to deliver guest lecturers to the students of the First Party on the "Life, Mission, Work and Literature of Dr. Ambedkar in requirements for departmental activities.

4.1 It is expressly agreed that First Party and Second Party are acting under this AOU as independent contractors, and the relationship established under this AOU shall not be construed as a partnership.
