  - **His/her official duties permit him/her to devote sufficient time for research.**
  - **If required, he/she will be relieved from the duty to complete the course work.**
- (ii) An undertaking that he / she will not join or continue any other course of study or appear at any examination after his / her enrolment to Ph.D. course till submission of the Ph.D. thesis as per clause 10.8 of Ph.D. ordinance.

After verification of the above-mentioned documents, the candidate can deposit the fee from **28.4.2023 to 1.5.2023 (up to 23:59)**. All the selected candidates are required to deposit Fee through online mode only at the admission portal ([iums.kuk.ac.in](http://iums.kuk.ac.in)) using his/her login ID and password.
