If a candidate is admitted on the basis of the information submitted by him/her, which is found to be incorrect or false or incomplete or modified at a later stage, or any misinterpretation/concealment of facts/errors/omissions/alterations is found, then his/her admission will be cancelled and all fees and other dues paid by him/her shall be forfeited.

After successfully verification of documents, the candidate can deposit the fee till 28th July 2023 (upto 2:59 hrs.). **The candidate will deposit the fee in online mode only through the University Admission Portal using their own login ID and password.
