4. *B.A. (Honors & Research) Programme (without apprenticeship under NEP (CBCS-LOCF)*

Accordingly, above said Template was implemented on the Institute of Integrated and Honors Studies, KUK from the session 2022-23. Further, the Deans’ Committee has finalized the revised Programme Structure Template for Undergraduate Programmes (Majors in Arts, Science and Commerce) as per NEP-2020 (Multiple Entry-Exit, Internships and Choice Based Credit System) in view of different UGC guidelines in its meeting held on 24.05.2022, which was approved by the Academic Council vide its Resolution No. 38 dated 22.12.2022 and by Executive Council vide its Resolution No. 20 dated 30.12.2022.

Now, the Director Higher Education, Haryana vide memo no. DHE-170006/11/2020-NPE dated 24.04.2023 has informed that a “Central Committee” of NEP Coordinators of the State Universities has been constituted to design the Curriculum and Credit Framework for implementation of NEP-2020 w.e.f. the academic session 2023-24 in all HEIs as per UGC Guidelines. Kurukshetra University has designed the Curriculum Credit Framework of Kurukshetra University, Kurukshetra for Under Graduate Programmes as per NEP 2020 for implementation in departments/colleges/institutes affiliated to Kurukshetra University. The Committee consisting of All Deans/Chairpersons/Directors/Principal of IIHS & ITTR and Controller of Examinations vide its minutes dated 23.05.2023 (**Annexure Pages 35(1-27)**) has approved the Revised 'Curriculum and Credit Framework of KUK of Under Graduate Programmes designed by the NEP Core Committee of Kurukshetra University according to National Education Policy 2020 and as per recommendations of the Central Committee of State Universities which is to be implemented in the affiliated colleges and on campus Programmes of the University w.e.f. session 2023-24.
