

The selected candidates are required to visit Institute of Law in person along with all original documents and two set of photocopy of the all documents for verification of same from **07.08.2023 to 09.08.2023 (9:00 am to 5:00 pm)**. The candidates, whose final year/semester examination is not declared yet, are required to submit an undertaking that he/she will submit the proof of passing final year/semester examination by the stipulated date mentioned in the HBI-23 failing which his/her provisional admission will be cancelled ab-initio and no fee will be refunded.

If a candidate is admitted on the basis of the information submitted by him/her, which is found to be incorrect or false or incomplete or modified at a later stage, or any misinterpretation/concealment of facts/errors/omissions/alterations is found, then his/her admission will be cancelled and all fees and other dues paid by him/her shall be forfeited.

After successfully verification of documents, the candidate can deposit the fee till **09.08.2023 (upto 23:59 hrs.)**. The candidate will deposit the fee in online mode only through the University Admission Portal using their own login ID and password.
