Subject:- Regarding introduction of 4th subject at UG level as Minor subject in the affiliated colleges under NEP 2020.

Sir/Madam,

Reference request(s) received from the Principals of affiliated colleges on the subject cited above I am desired to inform you:-

- (1) That the ordinances for U.G. Programmes under NEP 2020 for Multidisciplinary, Major and Inter-disciplinary programmes have already been passed by the Academic Council of the University and the number of subjects to be studied in each programme, are already mentioned in the corresponding Curriculum Frame work and schemes of examinations. As additional courses have come up in the revised curriculum framework of U.G. Programmes under NEP -2020, therefore, on the recommendations of the Committee Vice-Chancellor has approved that there is no requirement for a college/Institute to seek separate permission for teaching of Minor, MDC, AEC, VAC, SEC, VOC. Courses as additional subject(s) from the Colleges Branch which are mentioned in the different schemes of examinations.
- (2) In the case, when a college/institute has been running/offering only three subjects (courses) in a particular discipline (Arts/Life Science/Physical Science/Interdisciplinary programme), the college can introduce the 4th subject in that discipline to be offered as a Minor Course for the session 2023-2024 as per the Ordinance of that programme. The college will inform to the o/o Dean of Colleges and Controller of Examinations regarding such additional subject/course being offered as minor course withintime during the session 2023-2024. However, if a college/institute wants to offer any other subject as major subject in addition to the ones for which the sanction has already been given, the usual procedure/practice of the introduction a new subject will be followed by the colleges and necessary permission from the University along with applicable charges will be required.
- (3) These instruction are subject to ordinances and Framework of respective programme and the schemes of Examinations of the concerned courses which are strictly be followed by the college/Institute.

You are requested to follow the above guidelines/instructions.
