#### Policy for Administrative and Academic Audit of the University

#### Introduction

It is essential for a NAAC accredited University to assess its strengths and weaknesses periodically in order to keep pace with fast changing scenario in the field of higher education. Academic and Administrative Audit (AAA) is one of the standard strategies for quality enhancement in academic and administrative components including curricular aspects, teaching and learning, research, students progression support activities, governance, administrative setup of the University. AAA is focused on the processes by which University monitors its own academic standards and acts to enhance the quality of its teaching and support for student learning. AAA is important for achieving excellence in higher education.

Academic audit can be described as a scientific and systematic method of reviewing the quality of academic process in the University. It helps to enhance the quality of academic activities in the University. Administrative audit is a process of evaluating the efficiency and effectiveness of the administrative procedures of the University. It includes assessment of policies, strategies and functioning of the various administrative units, control of the overall administrative setup etc.

AAA of the University is required to confirm the quality assurance, availability of appropriate learning opportunities for the students and that students are fully supported in developing their academic personality. AAA is also required to promote and enhance high quality teaching and learning.

#### Objectives of AAA

- To understand the existing systems and assess the strengths and weaknesses of University Teaching Departments (UTDs)/Institutes and administrative units.
- To recommend the procedures for improvement by overcoming the weaknesses.
- To identify the opportunities for academic reforms, administrative reforms and examination reforms.
- To evaluate the optimum utilization of financial and other resources.
- To suggest the steps for continuous improvement of quality as recommended by accrediting agencies.

#### Process of AAA in the University

- AAA will be done once in three years by involving external peers.
- The formats for Academic audit and Administrative audit are enclosed at Annexure-A and Annexure-B respectively. These formats will be supplied to UTDs/institutes and administrative branches of the University.
- A committee of Dean of the faculty and 2 external experts (nominated by the Vice-Chancellor) will do academic audit of the departments of the respective faculty.
- A committee of 3-4 external experts will be constituted by the Vice-Chancellor for administrative audit of all branches of the University. The member-secretary of committee will be nominated by the Vice-Chancellor.
- The reports of AAA will be submitted to the office of IQAC.
- > The outcome of AAA may be placed in the meeting of IQAC and plan of action can be prepared to implement the suggestions accepted in the meeting of IQAC.

The committee constituted for academic audit of the departments under Faculty of Life Sciences visited different departments for the purpose on July 6 and July 11, 2022. Based on the information for the period 2017-2022 as provided in the preforms, observations of the committee in this regard are as follows:

Sr.No.	Name of Department/Institute
1	Institute of Environmental Studies
	The Institute has developed appreciable infrastructure and well equipped labs. The institute is doing good research as is evident from publications (60) with impact factor up to 11.889 and four research projects during this period. Faculty members and students have earned recognition/awards. The research collaborations with several national and international organizations are worth mentioning. As many as 32 students have qualified NET and 60 students have got placements. The Institute has organized good number of extension activities towards environment awareness in society.
	Suggestions:
	More efforts should be made for major projects and getting research grants from different agencies. The Institute has good scope for providing consultancy in soil, water, air quality assessment.
2	Department of Zoology
	During the past five years, the Department of Zoology have carried out quality research as can be seen from publications which include 109 research papers having very high impact factor (up to 17.01) and 6 books. The department is SAP (UGC) sponsored and has received a grant worth 65 lakhs. The faculty has published two patents also. The students and faculty members have earned awards/honors and 120 students have qualified NET. The number of PhD students getting fellowships is also high. Extension activities are also appreciable.
	Suggestions:
	Faculty should apply for more funds/research grants. Efforts should be made to provide consultancy by the staff in their specialised fields.

### Observations:-

- 1. The Department has published good number of qualitative research publications.
- 2. Research projects have been undertaken. However, very few faculty members, among presently serving faculties, have got research projects funded from external agencies.
- 3. Department has received grant under DST-FIST scheme of worth Rs. 2.0 crores.
- 4. Eleven patents have been submitted by the department's faculties and nine awards have been received.
- 5. The Department receives good support from the University in terms of space, infrastructure and grant. The department earns distinction having two separate buildings and an assistance for equipment/chemicals upto Rs.246 lacs from university funds.
- 6. The Department has shown a qualitative growth in publication. Impact factor average in the span of last five years has increased considerably in comparison to that of previous span. Overall, research output of the department is very good.

### Suggestions:-

- The faculty should strive for getting more research projects from external agencies.
   Funding from external agencies is less in comparison to that from University's own resources.
- 2. A part of the grant of Rs.246 lacsmay be used for renovation of chemical disposal system as per laid down norms.
- 3. Solar panels may be installed on the roof top of the one of the departmental buildings for energy audit purpose and connectivity of the two buildings is recommended.
- 4. Two big rooms/halls/labs may be merged into one to get a big multi-purpose hall.
- 5. Power backup for 2<sup>nd</sup> building, either in conjunction with that of old building or a new one, may be provided to the department.
- 6. Efforts should be made for having some research projects related to Environment studies as per requirement of the time.

7. Better coordination among all sections of the department is suggested for overall homogeneous growth of the subject.

#### Observations:-

- 1. The faculty of the department has published good number of research papers (166) out of which 72 are SCOPUS indexed. In addition six patents have also been generated.
- 2. The department is readily competent to give consultancy in eight areas but has not been able to generate any income out of it.
- 3. Two awards have been received by faculty members.
- 4. Rate of qualifying NET/JRF/GATE/AFCAT examinations is good &23 students have cleared such examinations. 22 students have advanced to Ph.D. Programme. 17 students have got scholarship for that.
- 5. Placement record of the department has been very good.
- 6. Citationscore of research publication is good.
- 7. Aproposto its potential, the number of research projectssubmitted& received is less.

### Suggestions:-

- Teachers should make efforts for submission &sanction of research projects from external agencies.
- Engagement of students for small software/app projects is the one of the areas where lot of possibilities can be explored.
- The department should be provided more flexibility in devising /attaining credits for course completion in one or more attempts, in particular for those students who are placed during the course itself.
- 4. In order to supplement the research work Databases like SCOPUS/Science Direct/IEEE should be subscribed at the university level either as a part of Consortium or in other form. This is a common requirement of all the science departments.

5. Vacant teaching& non-teaching posts should be filled.

- 1. The department has published good number (56) of qualitative publications.
- 2. The average citation index of the publications is 3.39 with average impact factor 1.558 and the average of h-index of active researchers of the department is 15.
- 3. 36 students have cleared NET/GATE/JRF and other competitive examinations which is a good score. The rich curriculum of M.Sc. mathematics programme forms the basis of this success.
- 4. Intake (150) of students in one class is very high and does not match with the existing infrastructural provisions and faculty strength of the department.
- 5. A large number of students (111) have been able to get financial assistance in different forms.
- 6. The departmental library is well stocked &maintained and the department has been distinctively receiving grant from National Board of higher Mathematics for library books.
- 7. The department has four ICT enabled class rooms but those are not specious enough.

**8.** The department has only four regular faculty members and two are non-Ph.D. There has been no recruitment in the department in last 26 years.

## Suggestions:-

- 1. As there is an acute shortage of regular faculty, the vacant teaching posts must be filled at urgent and priority level. As per the requirement, it is suggested that young faculty is appointed which is possible when appointments are made at Asstt. Professor level. So, the vacant 03 positions, in addition to the advertised 04 posts of Associate Professors, should be downgraded to assistant professor & advertised accordingly at the earliest with highest priority.
- 2. Intake of 150 students is very high & against UGC norms also, so intake must not be greater than 120 (2 sections) in any case.
- 3. The department has lack of space & infrastructure, it is, therefore, suggested that either a separate building be constructed for the Department of Mathematics or the one more floor (ground floor) of the present building be allotted to the department at the earliest. The present space for class rooms and labs is not fit for the present strength of the department in any way.
- 4. Teachers of the department should make sincere efforts for accelerating research activities and getting research projects.
- 5. The department should organize national/international conference/seminar/workshop and university administration should provide sufficient grant for that purpose.
- 6. The department has not held alumni meet in last five years, so that should be organized at the priority level.
- 7. The department requires immediate updating of its two computing laboratories in view of the fact that they have lab courses in all the four semesters of M.Sc. programme. It is suggested that a grant of Rs. 50.00 lacs should be provided for computers.
