

**IMPORTANT INSTRUCTIONS, QUALIFICATIONS & OTHER DETAILS**

1. **Appointment:** The appointment will be purely on contract basis under Khelo India Scheme to be governed by the guidelines issued by the Sports Authority of India from time to time and does not confer any right to claim to permanent employment in Kurukshetra University.
2. **Age Limit:** Maximum age limit for applicants will be 40 years. However, relaxation can be accorded in deserving cases.
3. **Tenure:** The contractual engagement will be initially for a period of 02 (two) years or till the Khelo India Scheme continues, whichever is earlier, which can be further extended on the basis of performance.
4. **Remuneration:** Fixed monthly remuneration of Rs. 25,000/- i.e. Rs. 3 lakhs per annum.
5. **Schedule of Walk-in-Interview: Date: 14.03.2024 Time: 11:00 A.M. onwards Venue: Directorate of Sports, Kurukshetra University, Kurukshetra.**
6. **Eligibility Documents:** The eligible and interested candidates may report with their original educational, professional, Sports achievement certificates, ID proof/Aadhar Card alongwith an attested copy of the same at Directorate of Sports(Kurukshetra University).
7. **Tax Deduction at Source:** The Income Tax or any other tax liable to be deducted, as per the prevailing rules will be deducted at source before effecting the payment, for which the Kurukshetra University will issue TDS/Service Tax certificates, as applicable.
8. **Other Allowances:** No TA/DA shall be admissible for interview and joining the assignment or on its completion. No other facilities like DA, Accommodation, Residential phone conveyance/transport, personal staff, medical reimbursement, HRA and LTC etc. would be admissible.
9. **Extension:** Performance of the selected candidates would be continuously reviewed and their extension will be considered on the basis of periodic review/requirement.
10. **Leave:** They will be entitled for 30 days leave in a calendar year on pro-rata basis. Un-availed leave in calendar year will lapse and will not be carry-forwarded to the next calendar year.
11. In case of performance is not found satisfactory, Kurukshetra University, Kurukshetra reserves the right to terminate the contract by giving 30 (thirty) days notice to the Past Champion Athlete and Kurukshetra University also may withdraw offer at any time without assigning any reason.
12. The decision of the University in all matters relating to acceptance or rejection of an application, eligibility/ suitability of the candidates, or the criteria for selection, etc. will be final and binding on the candidates. No inquiry or correspondence will be entertained in this regard.
13. The eligibility of every candidate will be determined on the basis of qualifications acquired and communicated to the office by him/her up to the date fixed for Walk-in-Interview.
14. Concealment of facts or supply of wrong information will result in cancellation of candidature in addition to legal action.
