- 2. Age Limit: Maximum age limit for applicants will be 40 years. However, relaxation can be accorded in deserving cases.
- 3. **Tenure:** The contractual engagement will be initially for a period of 02 (two) years or till the Khelo India Scheme continues, whichever is earlier, which can be further extended on the basis of performance.
- 4. Remuneration: Fixed monthly remuneration of Rs. 25,000/- i.e. Rs. 3 lakhs per annum.
