- 1. **Appointment:** The appointment will be purely on contract basis under Khelo India Scheme to be governed by the guidelines issued by the Sports Authority of India from time to time and does not confer any right to claim to permanent employment in Kurukshetra University.
- 2. **Age Limit:** Maximum age limit for applicants will be 40 years. However, relaxation can be accorded in deserving cases.
- 3. **Tenure:** The contractual engagement will be initially for a period of 02 (two) years or till the Khelo India Scheme continues, whichever is earlier, which can be further extended on the basis of performance.
- 4. **Remuneration:** Fixed monthly remuneration of Rs. 25,000/- i.e. Rs. 3 lakhs per annum.
- 5. Schedule of Walk-in-Interview: Date: 22.03.2024 Time: 11:00 A.M. onwards Venue: Directorate of Sports, Kurukshetra University, Kurukshetra.
